#### Worksession

#### 1. Call to Order

Mayor Doug Weiss called the worksession to order at 6:00pm. Mayor Pro Tem Kimberly Holiday and Councilmembers Jonathan Coffman, Ceasar Ruiz, Rudy Metayer, and Melody Ryan were in attendance. Councilmember David Rogers joined the worksession at 6:04pm.

#### 2. Regular Agenda

Discussion regarding the city's policy on calculating and publishing population estimates.

Mayor Weiss opened the item for discussion. Ms. Bailey reviewed the population growth and assumptions from 2019-2025 and discussed using the 2020 census for calculations. Mr. Griffin provided information about the calculation for dwelling units in the city. Ms Bailey stated the estimates are used for general growth trends. Mayor Weiss stated vacancy rates in multi-family are elastic. Discussion followed regarding vacancy rate models and the difference between single family and multi-family. Mr. Griffin answered questions from council about how dwelling units and population is calculated and discussion followed.

Ms. Ryan gave a presentation regarding population estimates. Council discussed what the population estimate is used for and how other cities estimate population. Mr. Griffin provided information about how the estimates are calculated. Ms. Ryan discussed how she calculated population estimates. Mayor Pro Tem Holiday discussed concerns regarding Ms. Ryan's presentation. Ms. Ryan discussed methodology differences. Discussion followed regarding data available. Ms. Ryan discussed how other cities calculate population estimates. Discussion followed regarding estimates in different housing categories.

Mayor Weiss asked if there was any desire to provide direction. Mr. Ruiz, Mayor Pro Tem Holiday, Mr. Coffman, Mr. Metayer and Mayor Weiss stated they comfortable with the current process. Ms. Ryan and Mr. Rogers stated they would like further discussion.
