1. Call to Order

PCDC Board President Darelle White called the PCDC Board side of the Joint Special Meeting to order at 6:35pm.

The discussion re-convened at 7:22pm as Item 2025-0518 was not resolved in the 5:00pm Joint Special Meeting.

3A. <u>2025-0518</u> Joint meeting with City Council and PCDC Board to discuss and consider action regarding Project Greenfield.

The Pflugerville City Council motioned to request that the Pflugerville Community Development Corporation (PCDC) Board of Directors issue the "Request for Qualifications" as a tool to approach the selection of an Owners Representative, with collaboration with City Staff, instead of the "Request for Quotes," which was released on June 6th. The PCDC board has withdrawn the Request for Quotes from all platforms. The Council directed the PCDC Board to release the Request for Qualifications for the Project Greenfield by the end of the week.

Per the direction and motion of the Council, after the initial Request for Qualifications (RFQ) process, the PCDC will pursue an Owner's Representative who will manage the project from start to finish as they work through the Executive Director of PCDC in alignment with the City Council, and PCDC Board of Directors vision for the site.

President White moved that PCDC give direction to the Executive Director to move forward with issuing a Request for Qualifications in conjunction with the feedback and information from the Pflugerville City Staff.
