Presentation regarding Quarter 2 FY22 Financial Update.

Mayor Gonzales opened the item for discussion. Ms. Moore gave a presentation about general fund revenue and answered questions from council about sales tax. Ms. Moore provided an overview of general fund expenditures and reviewed departments with council. Ms. Moore provided information about the water and wastewater fund revenue and expenditures, and the solid waste fund.

Mr. Aghamalian provided information about some of the types of items brought forward and answered additional questions from council about elections. Mr. Aghamalian provided information about some of the legislative discussions around sales tax. Mr. Aghamalian discussed the role of Focused Advocacy for the City of Pflugerville keeping the city informed on what is going on in the legislature. Mr. McDonald asked about what types of actions could be taken as it relates to gun violence with seeing a school shooting in Texas today.

Mr. Rogers discussed HB 1843 about expansion of emergency services districts. Mr. Aghamalian provided information about discussions around the topic.
