ASSIGNMENT AGREEMENT

This Assignment Agreement (this "Agreement") is made and effective as of ______ by and among ECM International, Inc. ("Assignor"); Johnson, Mirmiran & Thompson, Inc. ("Assignee"); and City of Pflugerville (the "Client").

WHEREAS, Assignor and Client are parties to one or more professional and consulting services agreements further described and identified on <u>Exhibit</u> A, hereto (each of which is referred to herein as the "Contract"); and

WHEREAS, effective October 1, 2022 pursuant to a Stock Purchase Agreement, Assignee acquired Assignor, and Assignor currently operates as a subsidiary of Assignee; and

NOW THEREFORE, in consideration of the mutual promises described herein, and other good and valuable consideration, with the intention of being legally bound, the parties hereto agree as follows:

- Assignor hereby assigns, transfers, sets over and conveys to Assignee its right, title and interest in the Contract [and any current task orders or project work authorizations issued under such Contract], and all benefit and advantage derived by or to be derived from the Contract, from and after the Closing.
- 2. Assignee hereby accepts the assignment and agrees to assume the rights and responsibilities to perform the Contract from and after the Closing in accordance with the terms, conditions, rights, and obligations contained therein.
- 3. Client consents to the assignment of the Contract to Assignee and hereby agrees that by this Agreement, the Assignee, shall be entitled to all rights, title, and interest of the Assignor in and to the Contract.
- 4. Hereafter, the term Consultant or similar defined terms used to refer to Assignor in the Contract, shall refer to Assignee. All notices required or necessary under the Contract relating to work performed by Assignee, and all payments due or owing shall be remitted and directed to:
