Discussion regarding the Downtown Utility Analysis: Overhead to Underground Utility Relocations.

Ms. Sellers introduced the item for discussion and Kevin Wolf from Cobb, Fenley and Associates to Council.

Mr. Kevin Wolf gave a presentation regarding placing utilities underground. Mr. Wolf answered questions from council and there was discussion regarding cost estimates for city. Mr. Wolf answered questions from council regarding needed equipment and current infrastructure. Discussion occurred regarding aging of current lines. Mr. Wolf said the process would take approximately nine months to a year and a half. Discussion followed regarding benefits of underground utilities, esthetic to City and current utility limits development.

Discussion regarding the Pflugerville Colorado River Water Supply Analysis and future water supply options.

Mr. Pritchett provided background information on the item. Mr. Pritchett introduced Ian Toohey from Garver and Ed McArthy, Legal Counsel for Water. Mr. Toohey gave a presentation and provided an update on some of the progress that has been done in the city. Mr. Toohey answered questions from council and discussed the Capital vs Cost Balance. There was discussion regarding flow rate, cost and peak capacity. Mr. Toohey estimated the total project cost at eighty-six million. Mr. Toohey answered questions regarding plan to do a Construction Manager at Risk approach. Project bidding expected in December of 2022. Discussion occurred regarding water supply and operations cost. There was additional discussion regarding real estate and expanding capacity
