#### Regular Meeting

#### 1. Call to Order

Mayor Doug Weiss called the meeting to order at 7:00pm.

Councilmember Rudy Metayer joined the meeting at 7:09pm.

- 4A.**     [ORD-0862](#)     Approving an ordinance on second reading with a caption reading: An ordinance of the City of Pflugerville, Texas, amending Ordinance No. 1203-15-02-24 of the City of Pflugerville, Texas, as amended, by rezoning Lot 2C of the Lot 2 Pflugerville Industrial Park Replat consisting of approximately 2.01 acres located along the east side of Weiss Lane, generally southeast of the Kelly Lane and Weiss Lane intersection, from Light Industrial (LI) District to General Business 1 (GB1) District, in the City of Pflugerville, Travis County, Texas, to be known as the PFL Weiss Investments LLC rezoning (REZ2025-00477); providing for repeal of conflicting ordinances; providing for severability; and providing an effective date.

- 4C.**     [ORD-0860](#)     Approving an ordinance as amended on third reading with the caption reading: An ordinance of the City of Pflugerville, Texas, amending the City of Pflugerville Code of Ordinances Title III Administration, Chapter 31 Departments, Boards and Commissions, to amend Sections 31.61, 31.62, 31.63 to transition the Equity Commission to an Equity Advisory Board, to amend Section 31.66 to amend board meeting requirements, to amend Section 31.76 to amend duties of the board, and to amend Sections 31.65 for consistency; providing that this ordinance shall be cumulative and repealing all ordinances in conflict; providing for severability; and declaring an effective date.

Mr. Rogers moved to approve the consent agenda. Mr. Coffman seconded the motion. Mr. Metayer was not in attendance for the vote. All those present voted in favor. The motion carried.

## 5. Public Hearings and Ordinances

- 5A. [ORD-0866](#) Conduct a public hearing regarding the Issuance of City of Pflugerville, Texas Combination Tax and Surplus Revenue Certificates of Obligation Series 2026A, and approving an Ordinance on first and final reading with the caption reading: Ordinance Authorizing the Issuance of City of Pflugerville, Texas Combination Tax and Surplus Revenue Certificates of Obligation, Series 2026A, in the Principal Amount of \$52,925,000 to Fund Waterworks System Improvement Projects and Awarding the Sale of Such Certificates of Obligation to the Texas Water Development Board.

Mayor Weiss read the item to open the public hearing. Ms. Waldron provided information stating it is the final funding for the project and that the amount is coming in less than anticipated. Ms. Ryan asked for information about the interest rates. Dusty Traylor, RBC Capital Markets, provided information about the certificates of obligation and answered questions about the process. There was no one present wishing to make public comment. Mr. Ruiz moved to close the public hearing. Mayor Pro Tem Holiday seconded the motion. All voted in favor. The motion carried. Mr. Metayer moved to approve the ordinance. Mr. Rogers seconded the motion. All voted in favor. The motion carried.

- 5B. [ORD-0867](#) Conduct a public hearing regarding the Issuance of City of Pflugerville, Texas Combination Tax and Surplus Revenue Certificates of Obligation Series 2026B, and approving an Ordinance on first and final reading with the caption reading: Ordinance Authorizing the Issuance of City of Pflugerville, Texas Combination Tax and Surplus Revenue Certificates of Obligation, Series 2026B, in the Principal Amount of \$27,180,000 to Fund Waterworks System Improvement Projects and Awarding the Sale of Such Certificates of Obligation to the Texas Water Development Board.

Mayor Weiss read the item to open the public hearing. Ms. Waldron stated it is the final funding for this project and discussed the approval from the Texas Water Development Board. Mr. Rogers asked questions regarding the impact of the approval. Ms. Waldron and Dusty Traylor, RBC Capital Markets, provided information about the certificates of obligation and stated the city will be paying a portion back from rates. There was no one present wishing to make public comment. Mr. Rogers moved to close the public hearing. Mayor Pro Tem Holiday seconded the motion. All voted in favor. The motion carried. Mr. Metayer moved to approve the ordinance. Mr. Coffman seconded the motion. All voted in favor. The motion carried.

## **6. Regular Agenda**

- 6A.**    [2026-0083](#)    Discuss and consider action to approve a construction contract with Patin Construction, LLC in the amount of \$2,820,654 for construction services associated with the Street Reconstruction Package 1C, and authorizing the City Manager to execute the same.

Mayor Weiss opened the item for discussion. Mr. Magee discussed the project as part of the pavement maintenance program in the Saxony subdivision and answered questions from council about timing. Ms. Ryan asked if this is the final package for the pavement maintenance program for the year. Mr. Groeschel stated there will be an item for preservation for the year. Mr. Ruiz moved to approve the item. Mr. Metayer seconded the motion. All voted in favor. The motion carried.

Mayor Weiss opened the item for discussion. Mr. Rogers asked why the number is set to \$50 million instead of \$42 million. Ms. Waldron provided information stating \$50 million was the number approved in the budget and discussed the number as a not to exceed amount. Dusty Traylor, RBC Capital, provided information about the issuing process. Mr. Rogers moved to approve the item with a not to exceed \$42 million. Ms. Ryan seconded the motion. All voted in favor. The motion carried.
