



BEING ALL OF THAT CERTAIN TRACT OR PARCEL OF LAND OUT OF THE JOHN VAN WINKLE SURVEY NUMBER 70, ABSTRACT 787, SITUATED IN TRAVIS COUNTY, TEXAS, SAID TRACT OF LAND BEING A PORTION OF A 26.930 ACRE TRACT OF LAND CONVEYED TO KB HOME LONE STAR. L.P. IN DOCUMENT NUMBER 2007226228. OF THE OFFICIAL PUBLIC RECORDS OF TRAVIS COUNTY. TEXAS. (O.P.R.T.C.TX), SAID 6.258 ACRE TRACT OF LAND BEING MORE FULLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING, at a 1/2" capped iron rod found at the northwest corner of Lot 1, Block D, Spring Trails, Phase One, a subdivision recorded in Document Number 200600202, (O.P.R.T.C.TX), also being in the southern right-of-way of Stargazer Way (50' R.O.W.), for the POINT **OF BEGINNING** of the herein described tract,

THENCE, leaving said Stargazer Way, and with the western boundary line of said Spring Trails Phase One, the following four (4) courses and distances, numbered 1 through 4,

- 1. S11°23'04"E, a distance of 102.04 feet to a 1/2" capped iron rod found,
- 2. S31°24'01"E, a distance of 101.28 feet to a 1/2" capped iron rod found,
- 3. S54°13'49"E, a distance of 271.45 feet to a 1/2" capped iron rod found, and
- 4. S45°06'42"E, a distance of 195.34 feet to a 1/2" capped iron rod found at the northern corner of Lot 11, Block D, Spring Trails, Phase Six, a subdivision recorded in Document Number , (O.P.R.T.C.TX.) also being on the southwestern boundary line of Lot 9, Block D, of said Spring Trails, Phase One, for the most eastern corner of the herein described tract,

THENCE, with the northern boundary line of said Spring Trails, Phase Six, the following three (3) bearings and distances, numbered 1 through 3,

S48°18'17"W, a distance of 124.99 feet to a 1/2" capped iron rod found at the western corner of said Lot 11, Block D, also being in the northeastern right-of-way of Autumn Sage Way, (R.O.W. varies), and continuing for a total distance of 174.99 feet to a 1/2" capped iron rod found in the southeastern right-of-way line of said Autumn Sage Way, same being a northern corner of said Spring Trails Phase Six, at a point of curvature to the right,
- 2. With said curve to the right having a radius of 725.00 feet, an arc length of 5.43 feet, and whose chord bears S41°28'53"E, a distance of 5.43 feet to a 1/2" capped iron rod found, for a southern corner of the herein described tract, and
- 3. S52°22'16"W, a distance of 130.32 feet to a 1/2" capped iron rod found on the eastern boundary line of Spring Trails Phase 1-B, a subdivision recorded in Document number 200700171 (O.P.R.T.C.TX.), same being the most northwestern corner of said Spring Trails, Phase Six, and also the most southern corner of the herein described tract, at a point of curvature to the left,

THENCE, with the eastern boundary line of said Spring Trails, Phase 1-B, the following fourteen (14) courses and distances, numbered 1 through 14,

- 1. With said curve to the left having a radius of 595.00 feet, an arc length of 37.85 feet, and whose chord bears N43°53'06"W, a distance of 37.85 feet to a 1/2" capped iron rod found,

- 3. N50°44'13"W, a distance of 64.98 feet to a 1/2" capped iron rod found.

- distance of 475.65 feet to a 1/2" capped iron rod found,
- 10. N12°04'01"W, a distance of 76.38 feet to a 1/2" capped iron rod found, 11. N78°36'56"E, a distance of 130.06 feet to a 1/2" capped iron rod found,

- With said curve to the left having a radius of 230.00 feet, an arc length of 5.53 feet, and whose chord bears N21°13'51"W, a distance of 5.53 feet to a 1/2" capped iron rod found,

THENCE, crossing said 26.930 acre tract, N78°32'14"E, a distance of 131.13 feet to a 1/2" capped iron rod found in the western

THENCE, crossing said Autumn Sage Way, N68°06'18"E, a distance of 59.65 feet to a 1/2" capped iron rod found in the eastern

THENCE, with the western boundary line of said Spring Trails Phase One, the following two (2) courses and distances, numbered 1 and 2,

GENERAL NOTES:

- 1. THIS SUBDIVISION IS LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF PFLUGERVILLE.
- PRIOR TO CONSTRUCTION IN THIS SUBDIVISION, DRAINAGE PLANS WILL BE SUBMITTED TO THE CITY OF PFLUGERVILLE FOR REVIEW. RAINFALL RUN-OFF SHALL BE HELD TO THE AMOUNT EXISTING AT UNDEVELOPED STATUS BY PONDING OR OTHER APPROVED METHODS.
- ALL STREETS, DRAINAGE, SIDEWALKS, WATER AND WASTEWATER LINES ARE TO BE CONSTRUCTED AND INSTALLED TO CITY OF PFLUGERVILLE STANDARDS.
- WATER AND WASTEWATER SYSTEMS SERVING THIS SUBDIVISION SHALL BE DESIGNED AND INSTALLED IN ACCORDANCE WITH THE CITY OF PFLUGERVILLE AND STATE HEALTH DEPARTMENT PLANS AND SPECIFICATIONS. PLANS AND SPECIFICATIONS SHALL BE SUBMITTED TO THE CITY OF PFLUGERVILLE WATER AND WASTEWATER DEPARTMENT FOR REVIEW.
- NO HOUSE IN THIS SUBDIVISION SHALL BE OCCUPIED UNTIL BOTH WATER AND WASTEWATER TAPS HAVE BEEN PURCHASED, INSTALLED AND INSPECTED BY REPRESENTATIVES OF THE CITY OF PFLUGERVILLE FOR CONNECTION TO THE WATER DISTRIBUTION AND WASTEWATER COLLECTION SYSTEM.
- PROPERTY OWNER OR HIS/HER ASSIGNS SHALL PROVIDE FOR ACCESS TO THE DRAINAGE EASEMENTS AS MAY BE NECESSARY AND SHALL NOT PROHIBIT ACCESS BY GOVERNMENTAL AUTHORITIES FOR INSPECTION OF SAID EASEMENTS.
- NO OBJECTS, INCLUDING BUT NOT LIMITED TO BUILDINGS, FENCES OR LANDSCAPING SHALL BE ALLOWED IN A DRAINAGE EASEMENT EXCEPT AS APPROVED BY THE CITY OF PFLUGERVILLE.
- 8. ALL DRAINAGE EASEMENTS ON PRIVATE PROPERTY SHALL BE MAINTAINED BY THE PROPERTY OWNER OR ASSIGNS.
- IN ADDITION TO THE EASEMENTS SHOWN HEREON, THE FOLLOWING PUBLIC UTILITY EASEMENTS ARE HEREBY DEDICATED: TEN FOOT (10') ALONG AND ADJACENT TO ALL STREET RIGHT-OF-WAY.
- 10. PUBLIC SIDEWALKS BUILT TO THE CITY OF PFLUGERVILLE STANDARDS ARE REQUIRED ON THE FOLLOWING STREETS AND AS SHOWN BY A DOTTED LINE ON THE PLAT: AUTUMN SAGE WAY AND DOGWOOD BLOOMS LANE
- 11. CONSTRUCTION PLANS AND SPECIFICATIONS FOR ALL SUBDIVISION IMPROVEMENTS SHALL BE REVIEWED AND APPROVED BY THE CITY OF PFLUGERVILLE PRIOR TO ANY CONSTRUCTION WITHIN THE SUBDIVISION.
- 12. ON-SITE STORM WATER DETENTION FACILITIES SHALL BE PROVIDED TO REDUCE POST-DEVELOPMENT PEAK RATES OF DISCHARGE OF THE 2 YEAR, 10 YEAR, 25 YEAR AND 100 YEAR STORM EVENTS.
- 13. STREETLIGHTS SHALL BE INSTALLED AND OPERATIONAL BY THE SUBDIVIDER WITH PUBLIC IMPROVEMENTS PER ALL CITY OF PFLUGERVILLE STANDARDS. A STREET LIGHTING PLAN SHALL BE APPROVED BY THE APPLICABLE ELECTRIC UTILITY PROVIDER AS WELL AS THE CITY OF PFLUGERVILLE.
- 14. ALL ELECTRIC UTILITY INFRASTRUCTURE INCLUDING BUT NOT LIMITED TO TELEPHONE, CABLE TELEVISION, ELECTRIC UTILITY LATERAL AND SERVICE LINES SHALL BE INSTALLED IN ACCORDANCE WITH THE CITY OF PFLUGERVILLE ENGINEERING DESIGN GUIDELINES.
- 15. THIS SUBDIVISON IS SUBJECT TO ALL CITY OF PFLUGERVILLE ORDINANCES RELATED TO TREE PRESERVATION.
- 16. WATER AND WASTEWATER SHALL BE PROVIDED BY THE CITY OF PFLUGERVILLE.
- 17. WASTEWATER AND WATER SYSTEMS SHALL CONFORM TO TCEQ (TEXAS COMMISSION ON ENVIRONMENTAL QUALITY) AND STATE BOARD OF INSURANCE REQUIREMENTS. THE OWNER UNDERSTANDS AND ACKNOWLEDGES THAT PLAT VACATION OR RE-PLATTING MAY BE REQUIRED AT THE OWNER'S SOLE EXPENSE IF PLANS TO DEVELOP THIS SUBDIVISION DO NOT COMPLY WITH SUCH CODES AND REQUIREMENTS.

18. COMMUNITY IMPACT FEES FOR EACH LOT SHALL BE PAID AT TIME OF BUILDING PERMIT AND AT THE ASSESSED RATE ESTABLISHED IN ORDINANCE NO. 891-07-06-26. WATER IMPACT FEES SHALL BE SUBJECT TO AGREEMENTS ESTABLISHED WITH THE TRAVIS COUNTY MUD NO. 5, AS MAY BE APPLICABLE.
