This Supplemental Agreement No. 4 to a contract for Professional Services is made by and between the City of Pflugerville, Texas ("City") and STV, Inc. ("Consultant"). City and Consultant may be referred to herein singularly as "Party" or collectively as the "Parties."

WHEREAS, the City and Consultant executed an Agreement for Professional Services ("Agreement") on the 30th day of March, 2020 for the Melber Lane project ("Project") in the amount of \$621,849.01; and

WHEREAS, the City and Consultant executed Supplement #1 for Professional Services on the 15th day of September, 2023 for the Project in the amount of \$0.00; and

WHEREAS, the City and Consultant executed Supplement #2 for Professional Services on the 30th day of July, 2025 for the Project in the amount of \$0.00; and

WHEREAS, the City and Consultant executed Supplement #3 for Professional Services on the 6th day of February, 2026 for the Project in the amount of \$91,960.00; and

WHEREAS, the City and Consultant desire to enter into Supplemental Agreement #4 for Professional Services for the Project in the amount of \$1,940,479.08 on the 25th day of August, 2026 to add schematic layout development, hydrology and hydraulic analysis, surveying, and project management for the extension of Melber Lane across Wilbarger Creek north of Pleasanton Parkway to Ashton Woods, PS&E from Cameron Road to Pleasanton Parkway, and Bid & Construction Phase Services to the Agreement; and

WHEREAS, it has become necessary to amend the Agreement to modify the provisions for the Scope of Services, Work Schedule, and Compensation; and

WHEREAS, it is necessary for the City to amend its agreements from time to time to comply with changes in state law relating to contracts of municipalities.

NOW, THEREFORE, premises considered, the City and the Consultant agree that said Agreement is amended as follows:

I.

Article II. Term shall be amended by changing the term of the Agreement to terminate on March 19, 2029.

Article III. Scope of Services and Exhibit A, shall be amended as set forth in the attached addendum to Exhibit A.

Article III. Work Schedule and Exhibit B, shall be amended as set forth in the attached addendum to Exhibit B.

Article IV. Compensation to Consultant and Exhibit C (Fee Schedule), shall be amended by increasing by \$1,940,479.08 the amount payable under the Agreement for a total of \$2,562,328.09, as shown by the attached Addendum to Exhibit C (Fee Schedule).

Except as amended hereby and as previously amended as indicated above, the terms of the Agreement shall remain unchanged and in full force and effect.
