RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS
ISSUING ORDER OF CANCELLATION FOR THE NOVEMBER 7, 2023 GENERAL
ELECTION AND DECLARING ELECTION OF UNOPPOSED CANDIDATES

WHEREAS, the City Council of the City of Pflugerville has called a general election for November 7, 2023, (“General Election”) for the purpose of electing Councilmembers for Place 2, Place 4, and Place 6; and

WHEREAS, the deadline to submit an application for place on the ballot for the General Election was August 21, 2023 at 5:00 p.m. and the deadline to file an application for write-in candidacy for the General Election was August 25, 2023 at 5:00 p.m.; and

WHEREAS, the City Secretary is the authority responsible for having the official ballots prepared for the General Election and on August 28, 2023, submitted to the City Council a “Certification of Unopposed Status of Candidates” for the November 7, 2023 City of Pflugerville General Election, attached as Exhibit A; and

WHEREAS, according to Section 2.053 of the Texas Election Code, if the City Council receives a Certification of Unopposed Status, it may declare each unopposed candidate elected to office;

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS, THAT:

1. The “Certification of Unopposed Status of Candidates” for the November 7, 2023 City of Pflugerville General Election submitted on August 28, 2023 and attached as Exhibit A, is hereby accepted.
2. The Order of Cancellation, attached as Exhibit B is hereby issued, cancelling the November 7, 2023 City of Pflugerville General Election.
3. Ceasar Ruiz is hereby elected to the office of Councilmember Place 2 and shall be issued a certificate of election in the same manner and at the same time as provided for a candidate elected at the election and shall take his respective office upon his qualification as provided by the laws of the State of Texas.
4. Rudy Metayer is hereby elected to the office of Councilmember Place 4 and shall be issued a certificate of election in the same manner and at the same time as provided for a candidate elected at the election and shall take his respective office upon his qualification as provided by the laws of the State of Texas.
5. David Rogers is hereby elected to the office of Councilmember Place 6 and shall be issued a certificate of election in the same manner and at the same time as provided for a candidate elected at the election and shall take his respective office upon his qualification

as provided by the laws of the State of Texas.
