Special Meeting

1. Call to order

Mayor Jeff Coleman called the special meeting to order at 6:05 p.m. Councilmembers Wayne Cooper, Brad Marshall, Starlet Sattler and Victor Gonzales were in attendance. Councilmember Omar Peña was absent. Councilmember Elect Mike Heath was in attendance. City employees attending: Brandon Wade, City Manager; Lauri Gillam, Assistant City Manager; Trey Fletcher, Assistant City Manager; Karen Thompson, City Secretary; Amy Good, Finance Director.

2. Resolutions

- 2A. [RES-0276](#) Approving a resolution canvassing the votes of the November 3, 2015 General Election.

Mayor Coleman read the results of the General Election: for Councilmember, Place 3, Omar Peña received 2,786 votes and Phil Osars Emia received 672 votes, and for Councilmember Place 5, Mike Heath received 1881 votes and Rudy Metayer received 1841 votes. Mr. Peña was elected as Councilmember Place 3 and Mike Heath was elected as Councilmember Place 5. Mr. Gonzales made a motion to approve the resolution declaring the official results. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

- 2B. [RES-0277](#) Approving a resolution canvassing the votes of the November 3, 2015 Special Bond Election.

Mayor Coleman read the results of the Special Bond Election: on Proposition 1 regarding the issuance of \$10,700,000 Tax Bonds for a new animal shelter, 1945 were "for" and 2192 were "against"; and on Proposition 2 regarding the issuance of \$9,500,000 Tax Bonds for street improvements to Weiss Lane, 2584 were "for" and 1500 were "against." Proposition 1 failed and Proposition 2 was approved by the voters. Mr. Gonzales made a motion to approve the resolution declaring the official results. Ms. Sattler seconded the motion. All voted in favor. The motion carried.

Mayor Coleman presented a certificate of election to Mr. Mike Heath. Judge JB Marshall administered the oath of office to Mr. Mike Heath for the office of City

Councilmember, Place 5. Mr. Heath provided comments.

Mr. Cooper made a motion to adjourn. Mr. Heath seconded the motion. All voted in favor. The motion carried. The meeting was adjourned at 6:12 p.m.
