1 Call to Order

5A Receive a semiannual report regarding the progress of the City's Capital Improvement Plan.

Ms. Morrison presented the Semiannual report regarding the progress of the City's Capital Improvement Plan (CIP). She provided a program overview. She said currently there are 68 active projects across 7 programs all in various stages from Preliminary Design to Construction. Mr. Pritchard went over to the Water, Wastewater and Reclaimed Water CIP projects that are underway. When asked about land acquisitions and facilities to be decommissioned, Mr. Pritchard said all land has been acquired. He said lift stations will be decommissioned, but since they have pipes going through them, these properties won't be sold. Mr. Pritchett also briefly discussed the Facilities Projects including Downtown East and the Public Works Complex. Mr. Groeschel discussed Transportation CIP. He went over current projects under construction and upcoming projects. Mr. Achee discussed the Parks and Recreation CIP projects. He provided highlights of Wilbarger Creek Park Phase 2, which includes trail connections and a dog park. Mr. Achee briefly went over other Park developments.
