Conduct a presentation on a semiannual report regarding the progress of the City's Capital Improvement Plan projects.

Mr. Rector gave an overview of the City's Capital Improvement Plan (CIP) projects. He mentioned there are 57 active projects in the CIP. Mr. Dunsworth went over the water and wastewater projects. He briefly discussed the Water Treatment Plant expansion and other projects currently in the design and the construction phase. Mr. Rector provided an update on the Downtown East and Public Works Complex facility projects. Mr. Raza reviewed the transportation projects under the design and the construction phases. He provided the timeframes for the various transportation projects in the CIP. Mr. Achee presented the park projects currently in progress. He mentioned that the Lake Pflugerville Phase 2 and the Destination Playscape projects are both in the design selection phase. Mr. Achee concluded by stating the 1849 Park Phase 2 is in the construction phase and nearly complete.
