Collaboration between partners serves college

Requests for proposal and competitive bids for contracts for the recent \$420 million bond package at Lone Star College were provided through an innovative partnership with Choice Facility Partners. Contracts were awarded for roofing, furniture, flooring, HVAC and other resource areas so that Lone Star College could complete the renovation and improvements using these competitively bid and awarded contracts.

Choice Facility Partner vendors collaborated: furniture manufacturer KI partnered with Office Design Concepts and Library Interiors of Texas on the library furniture for the new Lone Star College Health Science building in Tomball and with Hallmark Office Products on the Atascocita campus.

For the new library on the first floor of the Health Science building, KI was asked to closely match the library furniture that is on the main campus, and Library Interiors of Texas customized the bookshelves

to match the furniture being manufactured by KI.

"What [the librarian] wanted was kind of unique and different," said Dave Gaskins, educational facilities specialist, Library Interiors of Texas. "I wasn't exactly sure how we could make it."

Gaskins said they started by providing the professional design expertise to ensure safety was maximized in the space

plan for the library shelving. Then they developed a customized arch top with two types of wood, with a slat wall built in so they could hang plastic dividers on it.



"That is a benefit to the end user as well," said Watts. "With deals of more than \$100,000 we can negotiate with the dealer chosen, which makes for very competitive pricing."

At the new Atascocita campus, KI partnered with Hallmark Office Products to provide all of the student classroom chairs. He complemented Jerry LaTour

According to Randy Watts, KI sales specialist, nearly every Lone Star College campus has some KI furniture.

KI is a manufacturer, so sometimes works directly with the end user or at times through a dealer, like Office Design Concepts, which also has a Choice Facility Partners contract. ODC is designated as a HUB (Historically Underutilized Business), which is important to higher education. ODC was selected to do almost all the KI furniture at the new Lone Star College Tomball Health Science building.

Watts said using the Choice Facility Partners contract is helpful,

of Hallmark Office Products on the collaboration.

"He and I worked together perfectly," said Watts. "That's the biggest project we've ever done with an office products company."

KI has consistently been ranked number one nationwide for education furniture for the past six years by *Contract* magazine. They are the sixth largest contract furniture manufacturer in the United States.

Another project that Library Interiors of Texas recently completed using the Choice Facility Partners contract is the Patrick Heath Public Library, a \$7.2 million facility, completed in Boerne, Texas.

Kelly Skovbjerg, librarian, Patrick Heath Public Library, called it a "great pleasure" to work with Library Interiors of Texas to furnish the building. "They worked

extensively with us to create custom pieces, find appropriate fabrics and quality pieces," said Skovbjerg. "Of the multitude of vendors we worked with over the course of constructing the building, Library Interiors was the easiest, most responsive and customer-service oriented."

Library Interiors frequently does quite a bit of creative work and design to determine specifications for the furniture before a project can even be bid. And when there is a bid process, there is no guarantee they will get the work. "We go at risk and sometimes it is significant," said Gaskins.

A bill he introduced consolidated the rules for construction procurement and project delivery into one chapter of law (2267), which went into effect Sept. 1, 2011. It expanded the types of entities required to use these procedures to municipalities, counties, school districts, and colleges; universities are exempt.

He noted that the law does still allow the use of interlocal contracts and job order contracting, such as the Choice Facility Partners. Callegari said that using Job Order Contracting "will allow you to take on those projects you can't readily define." He encouraged people who appreciate having JOC as a construction method to let legislators know why it is valuable and how it can best be used.

"It is going to be extremely important to us that you come and testify when [JOC] comes up," said Callegari. "Our legislators need to understand Job Order Contracting better."

Callegari chaired the Committee on Government Efficiency & Effectiveness and anticipates it will further study procurement issues.

"If you see an issue you can give input on, please do," he said. We need your input."

Attorney Sarah W. Langlois with Ogden, Gibson, Broocks, Longoria & Hall, L.L.P., went into detail about the new Texas Government Code Chapter 2267 created for construction services. She noted that guite a number of details

were "plucked from Chapter 44" of the education code and moved over to 2267. The changes removed two options, design build and contract to construct, rehab, repair using construction manager; now there are seven approved construction methods. Also, additional considerations for procurement may be considered.

Langlois clarified the law regarding energy savings performance contracts, saying the law applies to new and existing school facilities. "The school district may contract with a provider of energy/water conservation measures to perform work related to, connected with, or otherwise ancillary to measures identified in the scope of the ESP contract," she said. "The school district is authorized to use any available money, other than money borrowed from the state, to pay for such services

and ... is not required to pay for costs solely out of savings realized under [the] ESP contract."

Langlois said the law allows for Job Order Contracting for "work of a recurring nature, where delivery times are indefinite, and where indefinite quantities and orders [are] awarded substantially on the basis of predescribed and pre-priced tasks." (Many Choice Facility Partners JOC contracts use the R.S. Means price book.)

Langlois said the law now specifies that boards must approve each job, task or P.O. over \$500,000. "You do not need to reprocure," she clarified. "You just need board approval for the increase."
