Mayor Gonzales opened the item for discussion. Mr. Hunter introduced the Capital Improvement Plan (CIP), project selection parameters, master plans, and long range planning. Mr. Hunter discussed CIP adoption and updates, and project progress. Ms. Waldron reviewed various funding sources for the CIP.
