ORDINANCE NO. 949-08-05-27

AN ORDINANCE AMENDING CHAPTER 153 OF THE CODE OF ORDINANCES FOR THE CITY OF PFLUGERVILLE, TEXAS, BY ADDING THE WASTEWATER MASTER PLAN AS AN ELEMENT OF THE COMPREHENSIVE PLAN; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, The City of Pflugerville desires to adequately plan for wastewater needs of the City as it continues to grow and expand;

WHEREAS, the consultant HDR was retained by the City of Pflugerville to develop the comprehensive Wastewater Master Plan for the Gilleland Creek, Wilbarger Creek and Cottonwood Creek watersheds;

WHEREAS, the City desires to incorporate the Wastewater Master Plan as an element of the Comprehensive Plan, adopted on December 14, 2004 and amended on April, 18 2005 and August 27, 2007;

WHEREAS, Chapter 157.301 (A) (4) establishes the procedures to amend the Comprehensive Plan;

WHEREAS, the Planning and Zoning Commission held a public hearing to incorporate the Wastewater Master Plan as an element of the Comprehensive Plan on April 21, 2008; and

WHEREAS, the City Council held a public hearing to incorporate the Wastewater Master Plan as an element of the Comprehensive Plan on May 13, 2008;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

<u>Section 1.</u> Chapter 153.01 COMPREHENSIVE PLAN of the Code of Ordinances of the City of Pflugerville, Texas is hereby amended by adding the following:

(D) Comprehensive Plan Amendments.

(1) The document entitled *Wastewater Management Plan, March 2008* prepared by the consultants of HDR is hereby incorporated as the wastewater element of the Comprehensive Plan by Ordinance <u>949-08-05</u>, adopted on May <u>27</u>, 2008.

Section 2. Effective Date.

This Ordinance will take effect upon its passage by three affirmative votes on first reading; provided that this Ordinance will be posted and adopted at a subsequent meeting in accordance with the provisions of Section 3.15(d) of the City Charter.

Section 3. Severability.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.
