This First Amended Agreement to a contract for Professional Services is made by and between the City of Pflugerville, Texas ("City") and Kimley Horn and Associates Inc. ("Consultant"). City and Consultant may be referred to herein singularly as "Party" or collectively as the "Parties."

WHEREAS, the City and Consultant executed an Agreement for Professional Services ("Agreement") on the 28 day of August 2018 for the Transportation Master Plan project ("Project") in the amount of \$234,126; and

WHEREAS, the City of Pflugerville desires to adequately plan for transportation needs of the City as it continues to grow and expand; and

WHEREAS, a Transportation Master Plan is a long-range plan that identifies transportation objectives, solutions and policies for the growing transportation needs of the city; and

WHEREAS, a roadway impact fee study will provide potential opportunities for roadway funding within the city limits; and

WHEREAS, the City and Consultant desire to enter into a Supplemental Agreement for Professional Services for the Project in the amount of \$85,000 on the to add a roadway impact fee study to the Agreement; and

WHEREAS, it has become necessary to amend the Agreement to modify the provisions for the Scope of Services, Work Schedule, and Compensation as provided for in Exhibit A; and

NOW, THEREFORE, premises considered, the City and the Consultant agree that said Agreement is amended as follows:

**1.**

Article II. Scope of Services and Exhibit A, shall be amended as set forth in the attached addendum to Exhibit A.

Article III. Compensation to Consultant, shall be amended by decreasing by \$85,000 the amount payable under the Agreement for a total of \$\$319,126.00.

**2.**

Except as amended hereby as indicated above, the terms of the Agreement shall remain unchanged and in full force and effect.
