#### All information provided in this application is public information pursuant to the provisions of the Texas Public Information Act.


The Library Board submits a 5-year comprehensive library plan; makes recommendations concerning library policy and procedure, programs, services, grants, and fundraising. The Library Board is composed of 7 regular members serving 2-year terms and 1 alternate member serving a 1-year term. The alternate member may vote if a regular member is absent.

Candidates are required to be registered voters of the City and to have resided within the corporate limits for at least twelve months preceding the appointment and must not be employed by or hold any other position in the City's government. All appointments are made by and at the discretion of the City Council. Because vacancies may arise before the next regular appointment period, all applications are kept on file until the next application period.

## Professional Experience

My career as an educator in the Public School System began as a Grade Two ClassroomTeacher in Columbus, Georgia, and for the Los Angles Public Schools, Los Angeles, California.

Implementation of the first *English-as-a-Second Language* (ESL at that time) in Sunnyvale, California in 1966, was quite an adventure for me. In addition, I was asked to create, develop, and implement the first *Bilingual Education Program* for the San Jose Unified School District, San Jose, California in 1969. I soon advanced into Teacher Training and Public School Administration in San Jose, California.

Upon returning to Texas, I continued my work as a Teacher Trainer for the Dallas Independent School District (DISD) at the DISD Area IV Teacher Education Center. In Austin, I held the position of a Math and Reading Specialist in the Austin Independent School District (AISD).

In 1984, I was appointed as an Education Specialist for the Texas Education Agency in the *Department of Curriculum Development*. I worked with Public School Districts in the 20 Regional Education Service Centers providing workshops for School District Superintendents, Program Directors and Central Office Administrators regarding Early Childhood Education — The newly established PreKindergarten and Kindergarten Programs.

I was accepted as a graduate student in the Department of Educational Administration at the University of Texas at Austin in a unique program, under the leadership of Dr. Nolan Estes, which specifically trained selected graduate students for the Superintendency. I received my Doctor of Philosophy in Educational Administration in 1990.

At the Southwest Educational Development Laboratory (SEDL), I held the position of Research Associate, working in the Area of *Leadership for Change*. My responsibilities included providing leadership for members in *The State of Texas Cadre* and writing documents and articles for publication.

As an Adjunct Professor for Concordia University at Austin, I taught in the School of Education and supervised student teachers. I also taught the course *Leadership in Business* in the Adult Degree Program (ADP) in the School of Business.

Currently, I am retired and as a published writer, I continue Postdoctoral Research, write curriculum documents, and children's books. I also continue writing for Educational Periodicals and serve as an educational consultant.

At this time, I also continue to support my Husband of 51 years, Ezekiel Robert Castro, in his career as a member of the Faculty at the Sarah and Ernest Butler School of Music, The University of Texas at Austin.

He began his Classical Music studies at the age of nine in the University of Texas at Austin [Junior] String Project in 1948, as one of the original ll children selected from the Austin Independent School District to participate in the first class under the Leadership of Dr. William Doty, Dean of Fine Arts and Albert Gillis, Director.

As an undergraduate student, my Husband then became the teacher. He taught in the [Junior] String Project and was conductor of Orchestras until graduation from Undergraduate School, Class of 1961, The University of Texas at Austin.

As my Husband states, "Music is my life and the opportunities I had to teach music, while in undergraduate school, at the University of Texas at Austin were priceless. I do not know where I would be if it were not for the gift of being selected to be among the first group of elementary school students to be in the [Junior] String Project at the age of nine."

After 50 years away from teaching in the [Junior] String Project while in undergraduate school, he has now "come home" to where he began his studies in 1948.

In addition, I offer support to my two Daughters-in-Law who are Incredible Educators in the Public Schools in the State of Texas. Of Course, my loving support is there for My Two Awesome Sons in their own professions: Christopher Robert Castro, Sr. as an Educator and Carlos Antonio Castro as a Scientist!
