

**ORDINANCE NO. \_\_\_\_**

**AN ORDINANCE AMENDING AND UPDATING THE CITY OF PFLUGERVILLE CODE OF ORDINANCES, TITLE V. PUBLIC WORKS, CHAPTER 53, WATER AND SEWERS, RECLAIMED WATER REGULATIONS; PROVIDING CUMULATIVE, REPEALER AND SEVERABILITY CLAUSES; PROVIDING FOR OPEN MEETING AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Pflugerville, Texas, recognizes that water available to the City and its water utility customers is a precious resource that is essential to the public health and safety and economic stability of the City; and

**WHEREAS**, the City of Pflugerville desires to adequately plan for water utility needs of the City as it continues to grow and expand; and

**WHEREAS**, the City previously updated and adopted the City’s Water and Sewers regulations under Chapter 53, of the City’s Code of Ordinances; and

**WHEREAS**, in accordance with updates to rules adopted by the Lower Colorado River Authority (“LCRA”), it is necessary to review, update and adopt reclaimed water regulations; and

**WHEREAS**, as authorized under law, and in the best interests of the citizens of Pflugerville, Texas, and its customers, the City Council deems it expedient and necessary to establish certain rules and policies for the orderly and efficient management of reclaimed water supplies.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

**Section 1:** That the Code of Ordinances, City of Pflugerville, Texas, Title V. Public Works, Chapter 53, Water and Sewers, Penalty, is hereby updated and amended to reflect Article VIII being renumbered as Article IX.

**Section 2:** That the Code of Ordinances, City of Pflugerville, Texas, Title V. Public Works, Chapter 53, Water and Sewers, Reclaimed Water Regulations, is hereby created and adopted as Article VIII and as set forth in Exhibit A attached hereto and incorporated for all purposes.

**Section 3:** That the recitals contained in the preamble hereto are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

**Section 4.** All ordinances or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters herein.

**Section 5.** Cumulative and Repealer Clause. This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, Texas, and shall not operate to repeal or affect any other ordinances of the City except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this Ordinance, in which event such conflicting provisions, if any, are hereby repealed to the extent of such conflict.

**Section 6.** That it is officially found, determined and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.

**Section 7:** This Ordinance will take effect upon its adoption by the City Council and publication of the caption hereof in accordance with Section 3.15(d) of the City Charter.


