#### Worksession

#### 2A. 2013-2183

Discussion regarding the Fiscal Year 2014 budget.

Mr. Wade presented on the Utility Fund budget and answered questions of the Council. Mr. Word and Ms. Gillam also provided input in the discussion. Mr. Wade presented on the budget schedule and requirements for setting a tax rate above the effective rate. Mayor Coleman stated that they talked about going to an actual 1/2 cent under the effective rate. Council discussion followed. Mr. Wade indicated that he did not have an objection to lowering the tax rate to 1/2 cent under the effective rate. Mr. Hyde provided information on Truth in Taxation requirements. Ms. Good provided a handout on the proposed changes to the budget for lowering the tax rate to 1/2 cent under the effective rate. The Council was in agreement with plans to lower to 1/2 cent under the effective rate and to not advertise for exceeding the effective rate.
