#### Worksession

Discussion regarding Historic Colored Addition Subdivision Art & Community Engagement.

Mayor Pro Tem Holiday opened the item for discussion. Ms. Miller gave an overview of the history of the area. Meme Styles discussed the history of the area and stated they are here on behalf of the African American History Corridor Group. Christine Robinson-Jama, Dr. Courtney Robinson, Sheri Marshall, Nicole Ehigie, Tara Godby, and Angela Kabeya introduced themselves as members of the group and discussed the history of the area, background, and purpose. Ms. Styles stated the request is to adopt the African American Corridor Project as a city initiative, provide funding support, collaborate on permitting, site identification, and long-term maintenance.

Ms. Ryan asked about a timeline. Ms. Styles stated a year and a half. Mr. Rogers stated he like the idea of enhancing Pflugerville's history and discussed options for the area. Ms. Styles discussed space and identity. Mr. Metayer discussed Pflugerville's history. Mr. Coffman stated the area becomes unique to Pflugerville by the efforts put in. Mr. Ruiz asked about ideas for art in the area. Ms. Styles discussed resilience, power, identity, and unity. Mr. Ruiz discussed the importance of a park and place to congregate. Mr. Rudy stated the area is an opportunity for people to come to and stay. Ms. Breland discussed the types of items staff will be reviewing. Mayor Pro Tem Holiday asked about it being presented to the Equity Board. Discussion followed regarding next steps for

presentation to the Equity Board.
