Joint Meeting with PflISD Board

1. Call to Order

Mayor Victor Gonzales called the meeting to order at 6:15pm. Mayor Pro Tem Kimberly Holiday and Councilmembers Doug Weiss and Melody Ryan were in attendance. Councilmember Rudy Metayer joined the meeting at 6:55pm. Councilmembers Cesar Ruiz and David Rogers were not in attendance.

2. Public Comment

Mr. Groeschel reviewed transportation capital improvement projects including Colorado Sand Drive, traffic signals, and Kelly Lane Phase 2. Mr. Groeschel discussed upcoming projects and projects in design, including Kelly Lane Phase 3, East Pflugerville Parkway, and Immanuel Road. Mr. Pritchett provided information about the Water Treatment Plant Expansion, Secondary Colorado River Raw Water Line, and other utility projects under way. Ms. Miga reviewed development projects including the Engineering Design Manual update and Roadway Impact Fee Study update. Ms. Mitchell asked about the Cameron Road Realignment. Mayor Gonzales discussed growth throughout the city.

- Ms. Miller and Eddie Solis with HillCo Partners provided an overview and the 89th Regular Legislative Session including November Constitutional Amendments, Special Sessions, and the City's interim priorities. Ms. Miller and Mr. Solis discussed what did and did not pass, and discussed focus areas including economic development, development tools, extraterritorial jurisdiction, and municipal authority and engagement.

- Holly Galloway, Leadership Development Director for Pflugerville ISD discussed the Pflugerville Pfriendly customer service initiative. Ms. Galloway discussed sending secret shoppers to campuses, setting standards, and the Pflugerville Pfriendly pledge. Ms. Ryan asked about measuring the success of the initiative. Discussion followed regarding Pflugerville Pfriendly implementation.

- Dr. Quintin Shepherd provided information about the promise of "3Es." Dr. Shepherd discussed having a post-graduation path for every student. Mayor Pro Tem Holiday asked about how to track. Dr. Shepherd discussed building mechanisms to track. Mayor Gonzales asked about identifying pathways for students. Mayor Pro Tem Holiday discussed the importance of human connection. Ms. Ryan asked about starting in elementary schools, students who drop out, and tracking employment. Dr. Shepherd provided information. Discussion followed regarding mentorship programs. Ms. Mayer discussed students with additional needs being included in the promise as well.
