3C.	<u>2023-1223</u>	Conduct introductions and take action to make appointments to the Parks and Recreation Commission for up to four regular members for two-year terms beginning January 1, 2024; and one alternate member for a one-year term beginning January 1, 2024.
3D.	<u>2023-1220</u>	Conduct introductions and take action to make appointments to the Finance and Budget Committee for up to two citizen members for two-year terms beginning January 1, 2024 and up to one Councilmember for a term ending following the 2024 General Election.

3H.	<u>2023-1230</u>	Discuss and consider action regarding the Mayor's appointment to the Personnel Appeal Board for a three-year term ending December 31, 2026.
