### 1. Call to Order

Mayor Victor Gonzales called the special meeting to order at 6:01pm. Mayor Pro Tem Doug Weiss and Councilmembers Ceasar Ruiz, Kimberly Holiday, Rudy Metayer, Jim McDonald, and David Rogers were in attendance.
