Worksession

1. Call to order

Mr. Wade spoke regarding his concerns for continuing a 1/2 cent reduction and the effects to the pro forma. He requested that during tonight's regular meeting that the City Council set the proposed tax rate at the roll back rate (\$0.5405) so they can discuss it further next week.
