As stated in the ForeverLawn Landscape 15 Year Limited Warranty & Closed Loop Warranty System (hereinafter, "Limited Warranty"), our two-year installation warranty is valid from the date of substantial completion of installation, and is valid for up to two years with a valid registration. If any portion of your installation should fail due to what ForeverLawn determines is normal traffic and usage with respect to this warranty, we will repair the improperly installed portion at no expense to you. Repair is the sole remedy under this warranty, and what is and is not repaired is more fully laid out in the Limited Warranty. Repair or replacement does not renew or extend the terms or duration of this warranty. The repair will be performed by the original installation provider, if possible, and during regular business hours, and we reserve the right to make changes to both of these. Client also agrees to accept a substitute install provider if necessary. If additional materials are required, client will be required to incur such costs. Under no circumstances will ForeverLawn Austin be liable for any direct, incidental, or consequential damages, either in the original installation, or any repair or replacement under the warranty. Further, under no circumstances will our liability arising out of or related to the installation of your turf exceed the total sum paid by client for the installation services at issue, including client's attorneys' fees and costs.

Product Warranty

ForeverLawn Inc. offers a 15-year limited product warranty with a Closed Loop Warranty System on all ForeverLawn products. All applicable product warranties are offered through ForeverLawn Inc, and not ForeverLawn Austin. As the dealer and installer, ForeverLawn Austin cannot be held liable for product warranty issues.

Terms & Conditions

Due to the nature of the product, ForeverLawn Austin its shareholders, officers, directors and employees shall not be responsible or liable for any damages to any utilities, pipes, plumbing, sprinklers, or any other underground items or systems installed upon the property of the customer.

TERMS: 50% deposit is required to begin job. Once ordered, artificial grass products are non-refundable. Customer agrees to pay Forever Lawn Austin the full balance due upon completion of installation. Method of payment shall be by cash, check, ACH or credit card (3% processing fee). Any other payment arrangements must be outlined in this contract at time of contract acceptance. All materials installed remain the exclusive property of Forever Lawn Austin until Customer makes product and installation payments in full. If full final payment is not received within thirty (30) days, any outstanding balance shall accrue interest at the rate of eighteen percent (18%) per year. In the event Customer and/or Project retains an attorney in conjunction with any dispute arising out of this contract, Customer and/or Project shall pay Forever Lawn Austin reasonable attorney's fees and all other costs and expenses of Forever Lawn Austin if Forever Lawn Austin is found not to be responsible. In any event of non-payment by Customer, Customer agrees to pay all of Forever Lawn Austin's costs of collection, including without limitation, reasonable attorney's fees.
