Tax Rate Definitions

No-New-Revenue Rate:

- The tax rate required to produce the same amount of tax revenue for the current fiscal year as the previous fiscal year on properties taxed in both years.

Voter-Approval Rate:

- The maximum rate allowed by law without voter approval via a mandatory election. The calculation includes a specified increase on the prior year operations and maintenance no-new-revenue rate plus the amount necessary to cover debt service.

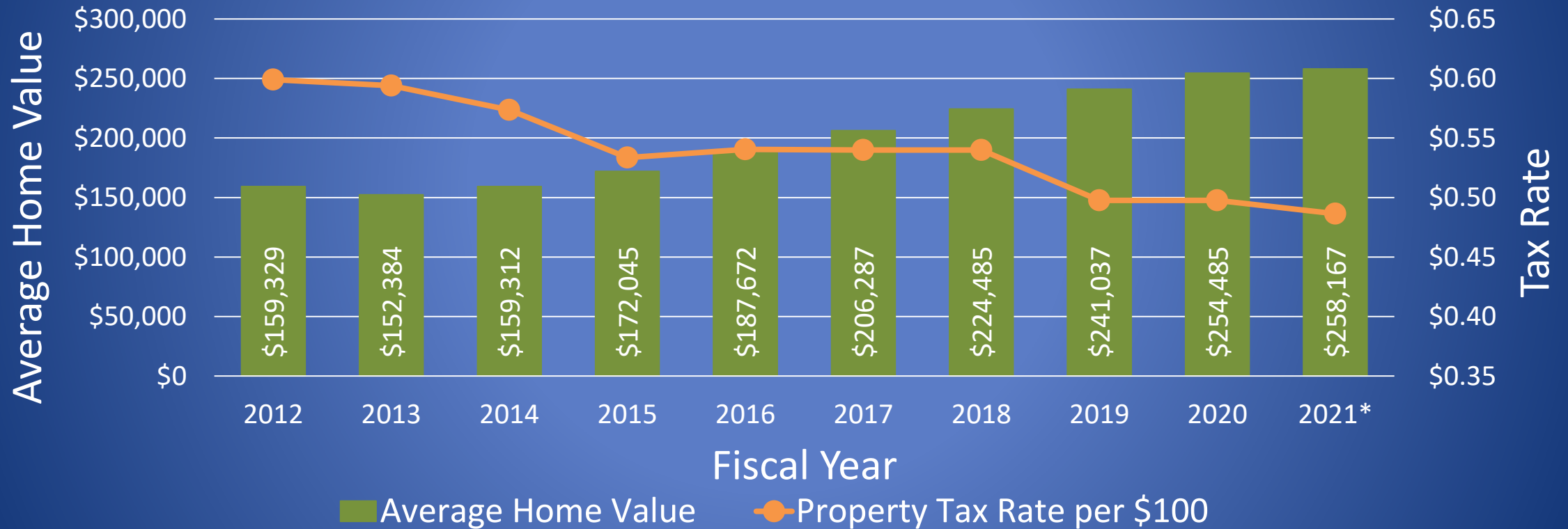

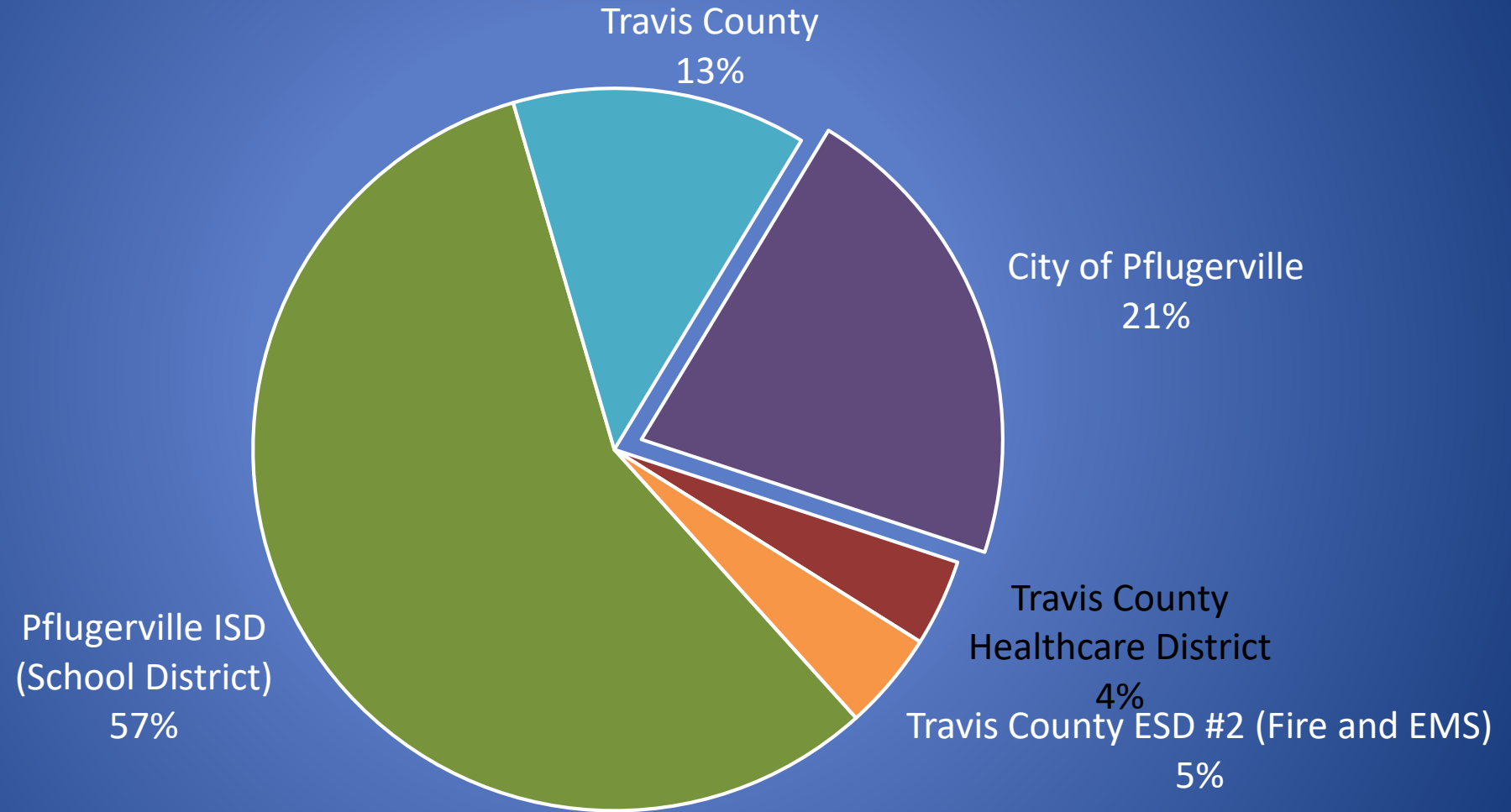

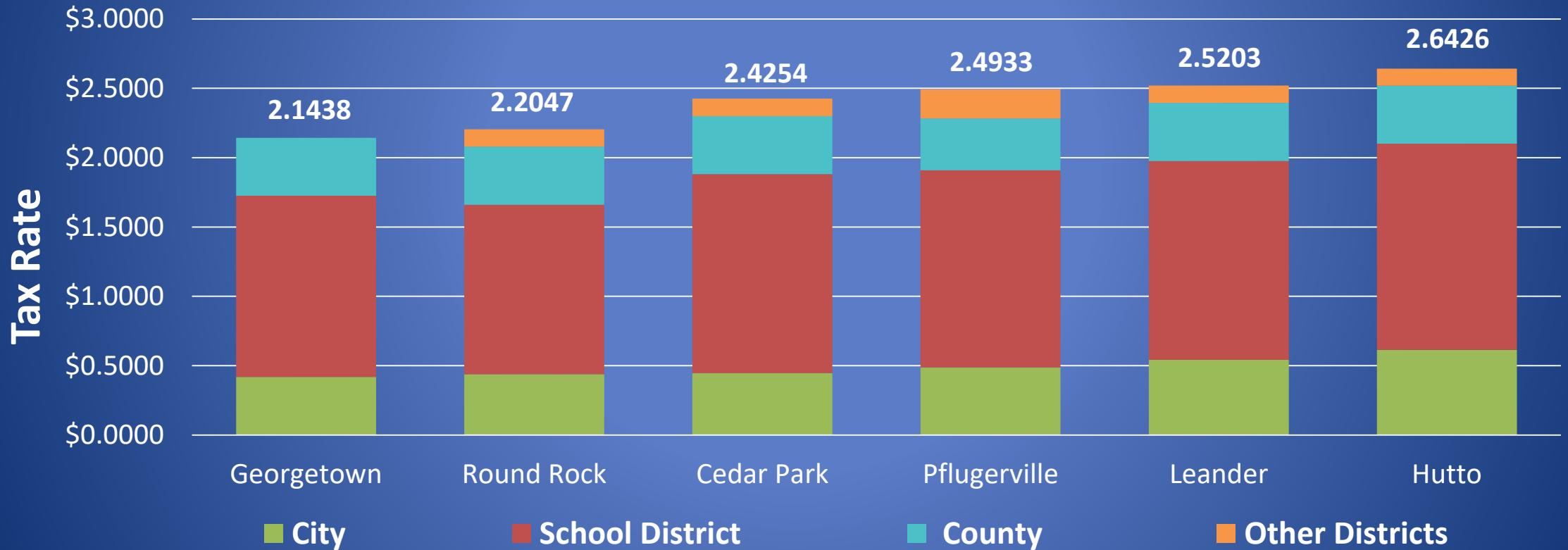


Combined Pflugerville Proposed Tax Rate





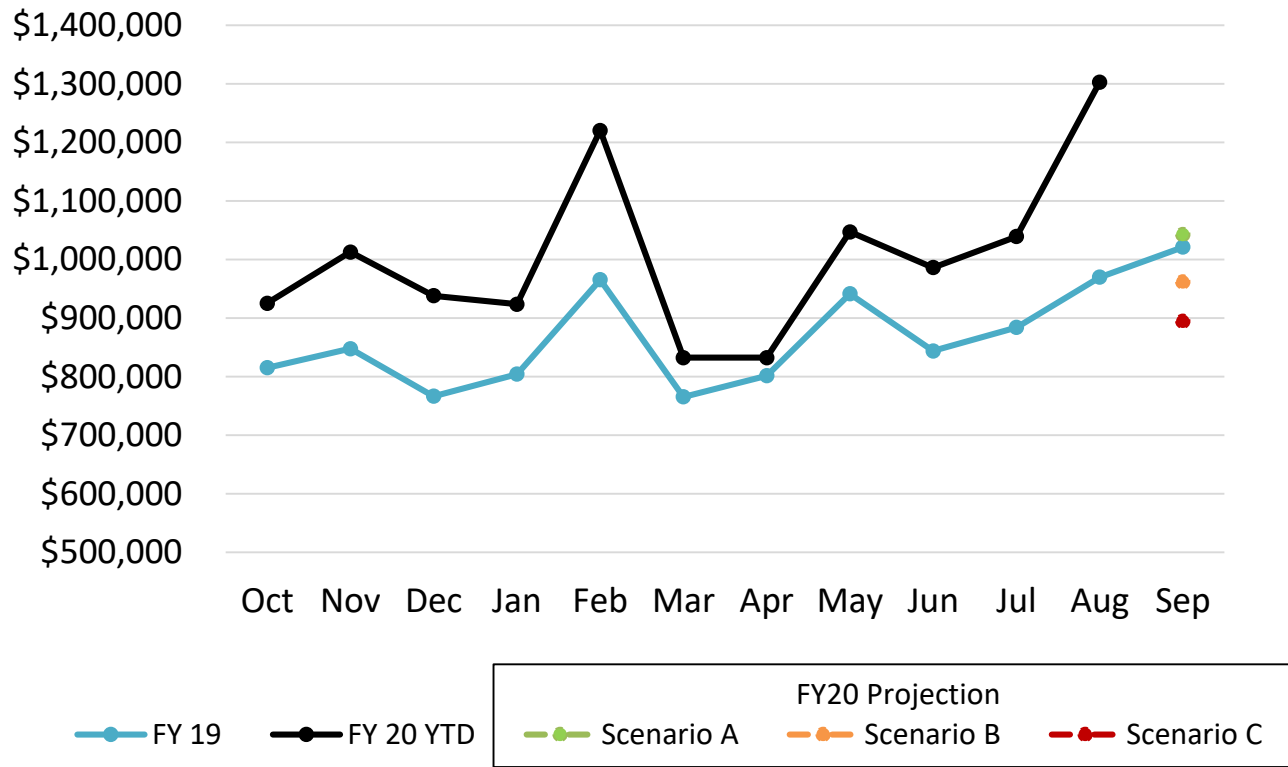
Overlapping Property Tax Rates



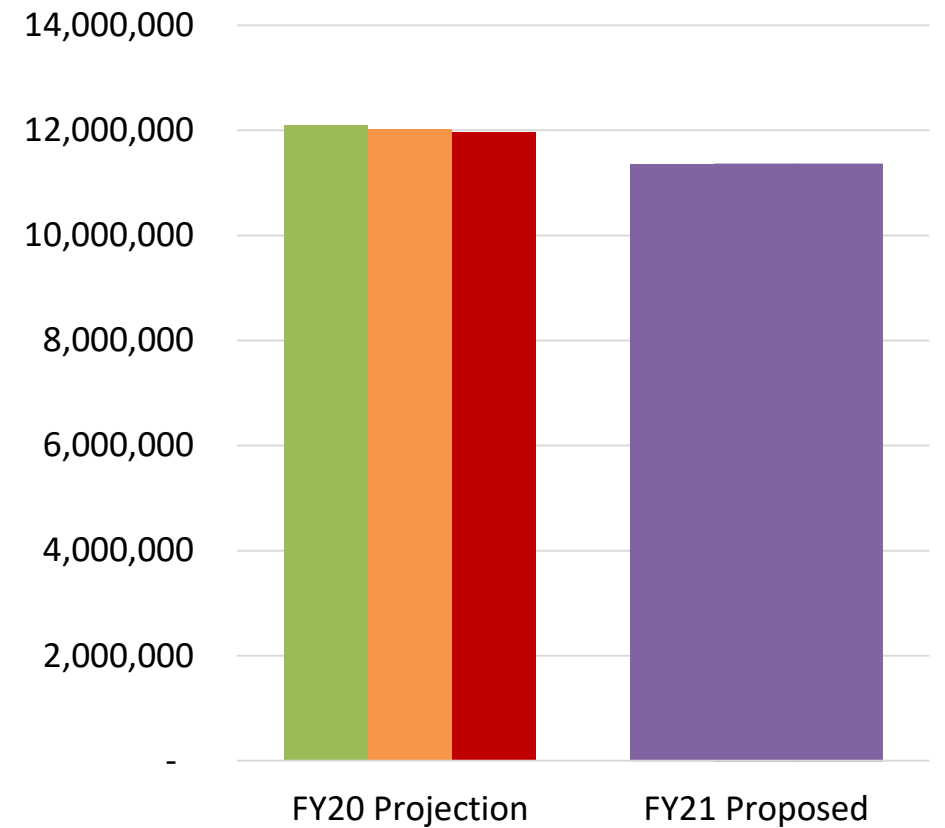


Sales Tax
