**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS APPROVING THE  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AMENDED  
ANNUAL ACTION PLAN FOR PROGRAM YEAR 2020.**

**WHEREAS**, the City of Pflugerville (City) is a Community Development Block Grant (CDBG) entitlement community as provided by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, as an entitlement community, the City prepared and submitted a 2019-2023 Consolidated Plan that details the goals and objectives to be implemented to address community needs in the areas of affordable housing, homeless services, special needs population and community and economic development needs; and

**WHEREAS**, as an element of the Consolidated Plan, the City is required to prepare and submit an Annual Action Plan detailing the activities to be undertaken annually to address the goals and objectives outlined in the Consolidated Plan; and

**WHEREAS**, the City adopted a Citizen Participation Plan in accordance with the requirements established by the U.S. Department of Housing and Urban Development to encourage citizen participation with emphasis for participation by persons of low or moderate income and low and moderate income neighborhoods, slum or blighted areas, and areas in which grantees propose to use CDBG funds; and

**WHEREAS**, the City Council held public hearings on November 10, 2020 and November 24, 2020 to receive input from citizens and agencies having interest in the CDBG program; and

**WHEREAS**, the proposed amended plan was made available for comment online from November 4, 2020 to November 24, 2020; and

**WHEREAS**, the City has met the requirements for citizen participation in preparation of this amended Plan and has allowed the opportunity for persons and agencies to identify needs and present concepts to help meet those needs through the CDBG program, as prescribed by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, for Federal Fiscal Year 2020 the City anticipates receiving a CDBG-CV award totaling \$158,241, to carry out activities that prepare, prevent, or respond to the coronavirus pandemic (COVID-19); and

**WHEREAS**, the CDBG Advisory Committee voted on November 2, 2020 to recommend approval of the 2020 1<sup>st</sup> Amended Action Plan;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

That this Program Year 2020 1<sup>st</sup> Amended Annual Action Plan, attached as Exhibit A, is approved.

**BE IT FURTHER RESOLVED** that the City Manager is authorized to submit the 2020 Amended Action Plan to the U.S. Department of Housing and Urban Development for their review and approval.
