Regular Meeting

1. Call to order

Mayor Pro Tem Victor Gonzales called the meeting to order at 7:10 p.m. Councilmembers Wayne Cooper, Mike Marsh, Darelle White, and Starlet Sattler were in attendance. Mayor Jeff Coleman was absent. 2. Opening

Mr. Marsh seconded the motion. All voted in favor. The motion carried.
