### 1. Call to order

Mayor Jeff Coleman called the special meeting to order at 6:00 p.m. Councilmembers Wayne Cooper, Starlet Sattler and Victor Gonzales were in attendance. Councilmember Brad Marshall entered the meeting at 6:05 p.m. Councilmember Omar Peña was absent. City employees in attendance: Brandon Wade, City Manager; Raika Rowe, Assistant City Attorney; Karen Thompson, City Secretary; Lauri Gillam, Assistant City Manager; Trey Fletcher, Assistant City Manager; Tom Word, Assistant City Manager; Amy Good, Finance Director; James Hemenes, Parks Director; Emily Barron, Planning Director; Chuck Hooker, Police Chief; Terri Waggoner, Public Information Officer. Amy Madison, Assistant Executive Director of the Pflugerville Community Development Corporation (PCDC), was also in attendance.

Items were addressed in the order as recorded in the minutes.

#### 2. Public Hearing

2A. ORD-0198 Conduct the second of two public hearings on an ordinance with the caption reading: TAX LEVY ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS.

Mayor Coleman opened the public hearing. There were no requests to speak at the public hearing. Mr. Gonzales made a motion to close the public hearing. Mr. Cooper seconded the motion. All voted in favor. The motion carried.

Mayor Coleman stated that city staff would like to receive a proposed tax rate number in order to prepare the final budget materials for adoption next week. Ms. Good and Ms. Gillam provided information. Discussion followed. Mr. Cooper, Ms. Sattler and Mr. Gonzales recommended setting the property tax rate at the rollback rate. Mr. Marshall and Mayor Coleman were in favor of lowering the property tax rate to lower than the rollback rate. Mr. Wade indicated that staff would prepare documents with the rollback rate and that the Council could consider it further next week during the adoption of the budget and tax rate. No action was taken.
