| <b>WHEREAS</b> , the Pflugerville Fee Schedule was adopted by Ordinance No. 1559-22-09-13 and included the ability to adopt modifications to the Fee Schedule by resolution rather than by ordinance; and   |
| WHEREAS, the Texas legislature approved House Bill 3492 which becomes effective   |

WHEREAS, the Texas legislature approved House Bill 3492 which becomes effective September 1, 2023 and precludes a municipality from considering the cost of constructing or improving the public infrastructure for a subdivision, lot, or related property development in determining the amount of a fee; and

WHEREAS, the fee for Construction (Public Infrastructure) Plan Due Upon Plan Approval and the New Commercial Building Plan Reviews have fees related to the value of a project as identified in the adopted Fee Schedule; and

**WHEREAS**, the proposed amendments explained and included herein as Exhibit A ensure compliance with the new state legislation and the fees will be published in accordance with House Bill 3492.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE:

That City Council hereby amends the value based Construction (Public Infrastructure) Plan and Building Plan Review New Commercial fees adopted in Ordinance No. 1559-22-09-13 and replaces value based fees with the fees and calculations provided in Exhibit A.
