**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS APPROVING A COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL ACTION PLAN FOR PROGRAM YEAR 2021.**

**WHEREAS**, the City of Pflugerville has become a Community Development Block Grant (CDBG) entitlement community as provided by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, as an entitlement community, the City prepared and submitted a 2019-2023 5 year Consolidated Plan, that details the goals and objectives to be implemented to address community needs in the areas of affordable housing, homeless services, special needs population and community and economic development needs; and

**WHEREAS**, as an element of the Consolidated Plan, the City must prepare and submit an Annual Action Plan detailing the activities to be undertaken annually to address the goals and objectives outlined in the Consolidated Plan; and

**WHEREAS**, the City of Pflugerville adopted a Citizen Participation Plan in accordance with the requirements established by the U.S. Department of Housing and Urban Development to encourage citizen participation with emphasis for participation by persons of low or moderate income and low and moderate income neighborhoods, slum or blighted areas, and areas in which the grantee proposes to use CDBG funds; and

**WHEREAS**, the City Council held public hearings on **June 8, 2021 and July 13, 2021** to receive input from citizens and agencies having interest in the CDBG program; and

**WHEREAS**, the proposed plan was made available for comment online and at the Pflugerville Public Library and the Travis County Community Center from July 2, 2021 to August 2, 2021; and

**WHEREAS**, the City has met the requirements for citizen participation in preparation of this plan and has allowed the opportunity for persons or agencies to identify needs and present concepts to help meet those needs through the CDBG program, as prescribed by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, for Federal Fiscal Year 2021 the City anticipates receiving a CDBG award totaling \$263,066, to carry out activities that meet one of the three National Objectives, as described by the U.S. Department of Housing and Urban Development; and

**WHEREAS**, the CDBG Advisory Committee voted on August 2, 2021 to recommend approval of the Program Year 2021 Annual Action Plan;

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:**

1. That this Program Year 2021 Annual Action Plan, attached as Exhibit A, is approved.

2. That the City Manager is authorized to submit the Program Year 2021 Annual Action Plan to the U.S. Department of Housing and Urban Development for their review and approval.
