AN ORDINANCE VACATING AN APPROXIMATELY 2.30 ACRES OF MEISTER LANE RIGHT-OF-WAY, SITUATED IN THE J. VAN WINKLE SURVEY, ABSTRACT NO. 787 AND THE P. CONRAD SURVEY, ABSTRACT NO. 200, IN THE CITY OF PFLUGERVILLE, TRAVIS COUNTY, TEXAS, BEING PART OF MEISTER LANE, A VARIABLE WIDTH RIGHT-OF-WAY, AND BEING MORE PARTICULARLY DESCRIBED IN EXHIBIT A; DECLARING THAT SUCH PROPERTY IS UNNECESSARY FOR USE BY THE PUBLIC; AUTHORIZING THE MAYOR OR CITY MANAGER TO EXECUTE A VACATION OF THE RIGHT OF WAY RELEASING PUBLIC INTEREST AND CONTROL OF THIS RIGHT-OF-WAY; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, the City of Pflugerville is a home-rule municipality acting in accordance with and pursuant to the powers enumerated in or implied by its city charter, as well as all powers of local self-government and all other powers, rights, privileges, and immunities, under the constitution and laws of the State of Texas; and

**WHEREAS**, Section 311.007 of the Texas Transportation Code authorizes a home-rule city to vacate, abandon or close a street or alley; and

**WHEREAS**, the City Council of the City of Pflugerville finds that the vacation of the 2.30-acre portion of Meister Lane public right-of-way situated in the J. Van Winkle and P. Conrad surveys, as denoted herein and more specifically depicted in Exhibit (A) is in the best interests of the public, as the pending right-of-way dedication and pending realignment and extension of proposed Kenney Fort Blvd. to the west will serve the transportation needs of the public while also further enhancing the property and economic development of the City;

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

- **Section 1.** That the recitals contain in the preamble hereto are hereby found to be true and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the Council.
- **Section 2.** That the City Council finds that such vacation will cause no harm or injury to the City of Pflugerville or its citizens.
- **Section 3.** That pursuant to the authority provided to the City by Section 311.007 of the Texas Transportation Code, the City Council hereby vacates the approximately 2.30-acre portion of Meister Lane right of way, out of the J. Van Winkle Survey, Abstract No. 787 and The P. Conrad Survey, Abstract No. 200, in the City Of Pflugerville, Travis County, Texas, and as more

fully depicted in Exhibit (A or B) attached hereto, is hereby vacated and abandoned as public property; the burden on the fee simple interests of the subservient estate pertaining thereto is hereby released.

**Section 4.** That should any section, clause, or provision of this ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of this ordinance or any other ordinance of the city as a whole or any part thereof, other than the part so declared to be invalid.

**Section 5.** That it is officially found, determined and declared that the meeting at which this Ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this ordinance, was given, all as required by Chapter 551, as amended, Texas Government Code.

**Section 6.** This Ordinance shall be effective upon the approval and recordation of a plat evidencing the vacated public street described herein.
