Recognizing that growth, I know that there is a growing need for citizen input into the administration of the city's financial management. It is my desire to give back to this community for the privileges it has afforded me and my family. I have a son and a daughter who also live here in Pflugerville along with their families.

I am a retiree of the Railroad Commission of Texas having retired in 1995 with thirty-seven years of service. During my tenure, I had extensive experience with budget development and management.

As the Director of the Administrative Services Division for the Oil and Gas Division early in my career, I was involved with the first state budget preparation utilizing the "zero base budgeting procedures" for the state of Texas. After development of the budget, I was responsible for budget control and evaluation for Administrative Services.

Later, for three years, I was the director of the Finance and Procurement Division of the Commission which was charged with all financial matters for the Commission to include budget development and management, purchasing of all equipment and supplies, disposal of surplus equipment, and compliance with all accounting procedures as set by the State Auditor's Office. I was also responsible for the leasing of all Commission office space outside of the Capitol complex which included ten remote statewide locations. At that time, the Commission had approximately 1,000 employees statewide with a multi-million dollar budget.

I finished my career as the Assistant Director of the Oil and Gas Division. In this position, I was more involved with compliance with the rules and regulations of the Oil and Gas Division, but I was also in charge of monitoring all division expenditures, purchasing, as well as budget preparation.
