AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES TITLE VII TRAFFIC CODE, CHAPTER 71 PARKING REGULATIONS, SECTION 71.05 PARKING PROHIBITED IN CERTAIN DESIGNATED AREAS BY ADDING ADDITIONAL TEMPORARY NO PARKING ZONES REQUIRED BY CONSTRUCTION; PROVIDING FOR A PENALTY FOR A VIOLATION OF CHAPTER 71 AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$200.00; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

**WHEREAS**, the City Council finds the City of Pflugerville is a Texas Home-Rule Municipality and that the City has the exclusive control over and under the public highways, streets, and alleys within the City, as established by Texas Transportation Code, Section 311.001;

**WHEREAS**, the City Council finds that upcoming construction within the Highland Park North subdivision is not conducive to on street parking during construction activities and it is necessary to establish additional no parking zones to protect the public health, safety and welfare; and

**WHEREAS**, the City Council finds that it has the authority to restrict parking under the Texas law.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

**Section 1. Findings.** The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

**Section 2. Amendment to Municipal Code of Ordinances.** The City of Pflugerville, Texas Code of Ordinances, Title VII (“*Traffic Code*”), Chapter 71 ( “*Parking Regulations*”), Section 71.05 ( “*Parking Prohibited in Certain Designated Locations*”) is hereby amended by adding language that is underlined (underlined) as follows:

**§ 71.05      PARKING PROHIBITED IN CERTAIN DESIGNATED LOCATIONS.**

(A) When signs are erected in the following locations reading substantially, "No Parking, Tow-Away Zone," it shall hereafter be unlawful for any person to park or stand any vehicle or trailer on the following parts of streets at any time, including but not limited to Sundays and holidays:

Highland Park North:

- a) Including - Obed River Drive, Kingston Lacy Boulevard, Alnwick Castle Drive, Abbyglen Castle Drive, Edinburgh Castle, Stokesay Castle Path, Portchester Castle Path, Busleigh Castle Way, Fyvie Castle Court, Blair Castle Court, Raglan Castle Path, Balmoral Castle Court, Kensington Castle Trail, Chrighton Castle Bend, Pendragon Castle Drive, Gladstone Castle Trail, Carlisle Castle Court, Rochester Castle Way, Dover Castle Lane, Old Wick Castle Way, Caisteal Castle Path, Windsor Castle Drive, Ripley Castle Cove, Huntingtower Boulevard, Stirling Castle Court.

**Section 3. Severability.** If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of this Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.

**Section 4. Repealer.** This ordinance shall be cumulative of all other ordinances of the City of Pflugerville, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Pflugerville except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

**Section 5. Effective Date.** This Ordinance will take effect upon its adoption by the City Council in accordance with Section 3.15(d) of the City Charter. The amended no parking zones established herein will automatically terminate upon completion of construction and removal of the temporary “No Parking, Tow-Away Zone” signs consistent with the same, at which time Section 71.05(A)(11) of this Ordinance shall be of no further force or effect.
