

RESOLUTION NO. 1808-20-11-10-0726

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE,
TEXAS CREATING AND APPOINTING MEMBERS TO A CHARTER REVIEW
COMMISSION**

WHEREAS, Section 11.11 of the Pflugerville Home Rule Charter requires the appointment of a charter review commission two years after the adoption of the charter and every five years thereafter; and

WHEREAS, the charter review commission must contain at least 13 members, and not more than 20 members, with three members appointed by the mayor, two members appointed by each of the council members and the remaining members appointed by the majority vote of the council; and

WHEREAS, Section 11.11 of the Pflugerville Home Rule Charter specifies that appointment shall be made at the first regular meeting following the anniversary date of the charter's adoption, which is the regular City Council meeting of November 10, 2020. **NOW THEREFORE**,
