Friends of the Pflugerville Library

Aaron Millis reported the Friends had another successful year in 2025. Highlights include raising \$2,000 on Giving Tuesday, raising over \$10,000 through book sales, and another \$5,000 in donations. The Friends supported the library with over \$9,000 for programs and also gave \$1,500 for teen volunteer scholarships. The Friends also donated books to local organizations and had over 1,200 volunteer hours contributed. Their next meeting will take place on January 20th and their next book sale on January 29th. The Friends also held their officer election choosing Aaron Millis as President, Kristen Ellisor as Vice President, Kimberlee Reist as Treasurer and Luke Brekke as Secretary.
