Mayor Gonzales opened the item for discussion. Mr. Pritchett presented a walkthrough of the Automated Metering Infrastructure portal and answered questions from council about the portal. Discussion followed regarding how the portal would be used. Mr. Pritchett provided information about how the portal was set up and how it can be used. Mr. Pritchett discussed the customer view and the options each customer has for notifications. Discussion followed regarding the lifespan of the equipment.

Mayor Gonzales opened the item for discussion. Mr. Dunsworth provided an overview of the project history, current structures, and facility conditions. Mr. Dunsworth discussed the details of the bids. Mr. Dunsworth answered questions from council about the design. Liz Horvath with MWM Design provided information about the design. Mr. McDonald asked if the building was designed prepared for flooded. Mr. Dunsworth provided information about the floor elevation for flood safety. Mr. Dunsworth discussed the timeline. Ms. Holiday

asked if there was shade in the area. Mayor Pro Tem Weiss asked about trees in the area. Mr. Metayer provided comment about the pool stating it is a great pool. Mr. Ruiz asked about use during summer 2023. Discussion followed regarding substantial completion Summer 2023.
