## KNOW ALL MEN BY THESE PRESENTS:

The undersigned, on behalf of **The Highlands Wells Branch**, **LLC**, a Texas limited liability company ("*Petitioner*") hereby petitions for the vacation of that portion of the Drainage Facilities Easement hereinafter described. In support of said Petition, I/we show the following:

- 1. The Petitioner listed in Paragraph 1, above, for itself and for its successors and assigns, for and in consideration of the vacation of that portion of the Drainage Facilities Easement described in attached Exhibits "A" and "B" and other valuable consideration, hereby releases, remises, and forever discharges the City of Pflugerville, its officers, agents, and employees, from any and all claims, actions, and damages, if any, whatsoever which they may have in law or equity with respect to any damage to its property as a result of the said vacation. This Release is not to be construed as an admission on the part of the City of Pflugerville of any liability in consequence of the above described vacation.
- 4. By the signature affixed hereto, the undersigned, on behalf of Petitioner, represents and warrants that Petitioner is the owner of the property as set forth in Paragraph 1 of this document and, as such, Petitioner is fully authorized to make this Petition.

## **PRAYER**

The undersigned, on behalf of Petitioner hereby prays that so much of said Drainage Facilities Easement as is described in <u>Exhibits "A" and "B"</u>, attached hereto, be vacated of record by the City of Pflugerville to the extent of public use thereof, and that said vacation be recorded in the Official Public Records of Travis County, Texas.
