# Minutes - Final City Council

#### Worksession

#### 1. Call to order

Mayor Jeff Coleman called the worksession to order at 9:05 a.m. Councilmembers Wayne Cooper, Brad Marshall, Omar Peña, Starlet Sattler and Victor Gonzales were in attendance. City employees attending: Brandon Wade, City Manager; George Hyde, City Attorney; Lauri Gillam, Assistant City Manager; Trey Fletcher, Assistant City Manager; Tom Word, Assistant City Manager; Karen Thompson, City Secretary; Terri Waggoner, Public Information Officer.

**2A. 2013-1897** Discussion regarding goals and objectives for the April 27, 2013 City

Council Worksession.

Mr. Wade provided information.

**2B. 2013-1898** Status report on the Fiscal Year 2013 budget and projections on the

Fiscal Year 2014 budget.

Ms. Gillam provided handouts with "Pflugerville at a Glance" information from the Popular Annual Report with number comparisons for FY 2006 and FY 2012 and information on the the Clnemark Sales Tax Rebate and discussed with Council. Ms. Gillam reported an increase in this year's assessed values of 5-6%. She stated that Finance is working on the requested pro forma with a 1/2 cent property tax reduction. Staff discussed with Council. Mr. Wade reviewed the budget schedule.

**2C. 2013-1903** Discuss the City Manager's Significant Activities Report.

Mr. Wade reviewed the proposed report format and stated that the intent is to provide the report to the Council with the packets for the first regular meeting of the month. The City Council provided suggestions on the report.

Mr. Wade reviewed the Strategic Plan update. Staff discussed with Council.

Ms. Waggoner presented information and suggestions to be taken from the survey. Staff discussed with Council.

#### 2F. 2013-1824

Discussion regarding Capital Improvement Program (CIP) roadway projects.

The City Council inquired if they needed to retire to executive session for discussion on the item. Mr. Marshall made a motion to retire to executive session under 551.071 of the Texas Government Code for consultation with legal counsel to discuss whether it was necessary to retire to executive session for discussion on the item. Mr. Peña seconded the motion. All voted in favor. The motion carried. Mayor Coleman announced that the City Council was retiring to executive session. The time was 10:50 a.m. Mayor Coleman reconvened in open session at 10:57 p.m. He announced that it was determined that the City Council would not need to retire to executive session on the item.
