Discuss and consider action to approve the appointment of the Police Chief.

Mayor Gonzales opened the item. Ms. Breland introduced Willie Richards and provided information about the recruiting process and his background. Mr. Weiss commended staff for working diligently with the community. Mayor Gonzales discussed the work of selecting a Police Chief and the importance for a growing city. Mayor Pro Tem Holiday stated she was excited to have him here and asked why diversity and inclusion is important for him and the police department.
