Regular Meeting

1. Call to Order

Mayor Victor Gonzales called the meeting to order at 7:00pm. Councilmembers Doug Weiss, Ceasar Ruiz, Rudy Metayer, Melody Ryan, and David Rogers were in attendance. Mayor Pro Tem Kimberly Holiday was not in attendance.

Ms. Miller reviewed council's current legislative priorities and asked about priorities moving forward. Mr. Weiss discussed the legislative agenda from CAPCOG and including it in community collaboration. Mr. Metayer discussed extraterritorial jurisdiction items as priorities. Mr. Solis provided information about economic development tools.

Jeff Whitacre with Kimley-Horn reviewed relevant supreme court cases and discussed the specifics of the development case. Discussion followed regarding system facility versus site-related facility. Mr. Whitacre reviewed the calculations and walked through the process. Ms. Miga answered questions from council regarding the development.

Steve Drenner with the Drenner Group spoke on behalf of the applicant and stated they disagree with some of the assumptions. Mr. Drenner reviewed the location of the property and history of the project. Mr. Drenner reviewed the government code and city ordinance and discussed the calculation of required exactions. Discussion followed regarding the legal parameters. Mr. Weiss asked about the discrepancy between the calculations and how the rest of the infrastructure gets built. Discussion followed regarding the calculations.

Mayor Gonzales stated council was retiring to executive session at 9:45pm. Mayor Gonzales reconvened the meeting in open session at 10:02pm.
