AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, AMENDING THE CITY OF PFLUGERVILLE, TEXAS CODE OF ORDINANCES, CHAPTER 154, REGARDING CHANGEABLE ELECTRONIC VARIABLE MESSAGE SIGNS (CEVMS) WITHIN THE CITY LIMITS AND THE EXTRA TERRITORIAL JURISDICTION OF THE CITY OF PFLUGERVILLE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Pflugerville has previously adopted a sign ordinance, codified under Chapter 154 of the City's Code of Ordinances; and

WHEREAS, the City of Pflugerville periodically amends its Sign Ordinance for the purpose of establishing reasonable regulations for all outdoor signs and structures that serve the purpose of a sign within the incorporated City limits and the City's extraterritorial jurisdiction in order to promote the economic development of the City while maintaining the quality of life for its residents and business owners; and

WHEREAS, THE City Council desires to provide certainty as to the regulations that will apply to signs within the City's corporate limits and extraterritorial jurisdiction; and

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE, TEXAS:

Section 1. Amendment to Chapter 154.112.

Chapter 154.112, Section (A) of the City of Pflugerville, Texas Code of Ordinances is hereby amended to read as follows:

(A) Be permitted for on-premises use in the corporate city limits and extraterritorial jurisdiction in the following corridors:

Pecan Street from its intersection with Central Commerce Drive to the Central Business District overlay boundary.

Farm Road 685 from the southernmost point at the City limits to its intersection with Pflugerville Parkway.

Pflugerville Parkway from its intersection with Farm Road 685 to its western edge of the city limits.

The entire length of Grand Avenue Parkway.

The entire length of A.W. Grimes Boulevard.

The entire length of Wells Branch Parkway.

The entire length of Farm Road 973.

Immanuel Road from E. Pecan Street to Wells Branch Parkway.

Railroad Avenue from the Central Business District overlay boundary to Pflugerville Parkway.

Section 3. Effective Date.

This Ordinance will take effect upon its passage and adoption by the City Council.

Section 4. Severability.

Denton, Navarro, Rocha, Bernal, Hyde & Zech P.C.

If any provision of this Ordinance is illegal, invalid, or unenforceable under present or future laws, the remainder of the Ordinance will not be affected and, in lieu of each illegal, invalid, or unenforceable provision, a provision as similar in terms to the illegal, invalid, or unenforceable provision as is possible and is legal, valid, and enforceable will be added to this Ordinance.
