#### **Regular Meeting**

#### 1. Call to order

Councilmembers Brad Marshall, Omar Peña, Starlet Sattler and Mayor Pro Tem Victor Gonzales were in attendance. Mayor Jeff Coleman and Councilmember Wayne Cooper were absent. Items were addressed in the order as recorded in the minutes.

Approving an ordinance on first reading with an agenda caption reading: AN ORDINANCE OF THE CITY OF PFLUGERVILLE, TEXAS, GRANTING A PETITION BY SORENTO HOLDINGS 2012, LLC FOR VOLUNTARY ANNEXATION AND ANNEXING, FOR FULL PURPOSES, A 2.624 ACRE TRACT OF LAND OUT OF THE REMAINING PORTION OF A CALLED 119.023 ACRE TRACT

RECORDED IN DOCUMENT NO. 2012164042 OF THE OFFICIAL PUBLIC RECORDS OF TRAVIS COUNTY, TEXAS, OUT OF THE JOHN C. Construction Project Management for the Lake Pflugerville North Parking Lot expansion and authorizing the City Manager to enter into negotiations regarding a scope of work and fee proposal.

Ms. Sattler seconded the motion. All voted in favor. The motion carried.

Mr. Marshall made a motion to approve the ordinance on first reading with the ordinance to become effective immediately. Mr. Peña seconded the motion. All voted in favor. The motion carried.
