A. Outline a brief history of the program area supported. Be sure to include current population of the jurisdiction served.

The Drop by Drop Rebate Program was initiated on March 2, 2001 in Pflugerville when the population was barely at 12,000. Since then population has grown to right at 50,000 and counting. The nature of the program is to offer residents options for their landscape gardens or turfs. The program offers guidelines and plant recommendations that are low water use or drought tolerant. It also allows resident to re-do their turf by using low water use grasses such as common Bermuda, buffalo grass and Zoysia grass as well as Habiturf which is a fairly new native species mixture. These grasses present the same aesthetics as St. Augustine with the exception that they are more drought tolerant, thus require less watering on a weekly basis. The first 10 years of the program, rebates were made in excess of \$28,000 which average approximately \$2,800 annually on 8 customers per year for an average of \$350 each. The last two years (2012 and 2013) \$17,966.69 were paid out as rebates. The combine customer expense for these two years was \$71,489.25. In 2012 twenty one customers used the program; in 2013 forty seven customers used the program. The rebates average 24% versus 75% customer expense.

- B. Describe in detail the programs and services offered by the individual/service agency. The Drop by Drop Manager sets up site visits with homeowners to go over final plan design and to review the application before it is submitted. After the initial site visit, the program manager send the customer an electronic letter indicating their project has been approve and lets them know they can commence their project. Once the project is completed, a follow up visit is made by the manager to assure the plants, bushes and trees were installed according to their original plan. Pictures are taken receipts are collected by the manager to submit for rebate if all criteria are met and if project is considered certified as completed. The manager proceeds to send final paper work to finance for rebate to the homeowner, which they should receive within 4 to 6 weeks after completion.

 The program is geared at all Pflugerville residents within the city limits or utility customers that may reside in the ETJ of Pflugerville. It is open to HOAs, POAs and businesses if they chose to utilize the program. In 2012 the program was used in 7 neighborhoods. In 2013 the program was used in 17 current and new neighborhoods.

 This program has been highly effective and has gotten more popular due to the current drought conditions. The Program has been highlighted by KXAN the NBC affiliate and

KVUE the ABC affiliate and KEYE the CBS affiliate in Austin as well as numerous newspaper articles in the Austin Statesman, The Pflugerville Pflag and The Community IMPACT as well as neighborhood newsletters and websites. The quick response from the manager minimizes the waiting time for the residents. This helps them obtain the proper plant communities from their nurseries in a timely manner. The service provided to them expedites the entire process and alleviates any concerns about missing windows for planting or purchasing their plants. The program is ongoing and has helped many homeowners reduce water use by planting low water use plants, shrubs and trees. The program guide is self-explanatory with schematics as to how to design their landscape and plant shade trees. It also has a list of approved plants.
