### Worksession

## 1. Call to order

## **Executive Session**

Mayor Coleman announced that the City Council was retiring to executive session on items 2B, 2C and 2D. He read the items to be discussed and retired to executive session. The time was 6:02 p.m.

**2B**. <u>2012-1535</u>

1.)Executive Session Item: Consultation with legal counsel regarding agreements with Manville Water Supply Corporation pursuant to Chapter 551.071 of the Texas Government Code.

1.)Executive Session Item: Consultation with legal counsel pursuant to Chapter 551.071 of the Texas Government Code for legal advice regarding a request for approval of Assignment and Consent of the City of Pflugerville, Texas to the Assumption of the New Sweden Development Agreement.

### **2A**. <u>2012-1534</u>

Discuss basic components of the municipal utility districts and water control and improvement districts in Pflugerville and its extraterritorial jurisdiction.

Mr. Fletcher provided information and answered questions of the City Council. Mayor Coleman asked Council if they would like more in depth information in the future. Mr. Peña indicated yes. Mr. Cooper asked for an informational spreadsheet. Mr. Gonzales asked in terms of the agreements, if there is anything that they can use to forecast projections for future development. Mayor Coleman stated that he would like to see that the Council has a foundation of knowledge regarding MUDs so they are making wise decisions for the future. He stated that he would like a MUD policy discussion as a future item. Mayor Coleman stated that he anticipates that the City of Pflugerville will, over the next five years, go through the growth that it experienced from 2003 to 2007. He stated that he anticipates that they will see pressure to do more of these and that he wants the Council to have information before those requests come forward. He requested to hold the policy discussion by the end of January or no later than the first meeting in February. He stated that he thinks this is one of the most important issues.

Mr. Cooper made a motion to close the worksession. Mr. Gonzales seconded the motion. All voted in favor. The motion carried. The worksession was adjourned at 7:01 p.m.
