ARTICLE 1 - GENERAL

WITNESSETH: That the City and the Owner's Representative, for mutual considerations herein contained and specified, have agreed and do hereby agree as follows:

ARTICLE 2 – SERVICES BY THE CONSULTANT

- 2.1 The Owner's Representative agrees to perform the following work in Phases and/or Parts and only if authorized by the City in subsequent written authorization(s) to proceed.
 - 2.1.1 Extend the contract duration to coincide with the contractual completion date of April 13, 2013 of which the General Contractor is obligated to.

ARTICLE 3 – CONTRACT CERTIFICATION

It is further agreed by the Owner's Representative that this Supplemental Contract shall in no way constitute breach of the original contract.

It is further understood and agreed by and between the City and the Owner's Representative that as to all other work under the original contract that the covenants, provisions, terms, and conditions thereof shall be binding and that the purpose of this Supplemental Contract is for the changes outlined above: additional funding.
