**RESOLUTION OF THE CITY OF PFLUGERVILLE, TEXAS AMENDING THE FOOD AND HEALTH INSPECTION FEES TO INCORPORATE LATE PAYMENT PENALTIES.**

**WHEREAS**, the City Council has ordained that the City of Pflugerville become the regulatory agency administering the Food Establishment Ordinance (Chapter 110 of the Code of Ordinances, hereinafter “Chapter 110”) and public pool inspections (Section 150.20 of the Code of Ordinances, hereinafter “Section 150.20”); and

**WHEREAS**, renewing food establishments and public pools have not always paid the fees for permitting and inspection mandated by the applicable ordinances in a timely fashion; and

**WHEREAS**, the City Council desires to amend the fee structure applicable to the Food Establishment Ordinance (Chapter 110) and applicable to swimming pools (Section 150.20) to incorporate late payment penalties.

**NOW THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PFLUGERVILLE:**

The fee schedules applicable to the Food Establishment Ordinance (Chapter 110) and swimming pools (Section 150.20) are amended to incorporate late payment penalties as reflected in Exhibit A.

Permanent Food Establishment permit <ul style="list-style-type: none"> <li>• 2 TFER* inspections</li> <li>• No fee for one re-inspection, per permit year, if required</li> </ul>	\$400 / Year
Mobile Food Vendor (Hot and Cold Truck) and Seasonal Vendor permits	\$200.00 / Year or Season
Temporary Event permit <ul style="list-style-type: none"> <li>• 1 TFER* inspection</li> </ul>	\$50.00
Complaint Investigation <ul style="list-style-type: none"> <li>• 2nd and subsequent TFER* inspection(s)</li> </ul>	\$50.00
Consultation Services beyond the aforementioned scope of services: <ul style="list-style-type: none"> <li>• Health Plan review,</li> <li>• Health Final and CO inspections and/or for more than one re-inspection</li> <li>• Food Establishment Plan review (new construction, remodel, or addition)</li> </ul>	\$100.00/hour
<b>Swimming Pools / Splashpads</b>	
Public Swimming Pool Permits <ul style="list-style-type: none"> <li>• 1 inspection per year</li> <li>• No additional fee for one re-inspection, per permit, per year if required</li> </ul>	\$200 / Year / Pump System

### **Late Payment Penalties**

- Payment is due within 30 days of the date on the invoice.
- If payment is 1-10 days late, a penalty of 25% of the fee shall be assessed.
- If payment is 11-30 days late, an additional penalty of 25% of the fee shall be assessed.
- If payment is not received within 31 days, the permitted establishment/pool is subject to closure.
