Mayor Pro Tem Kimberly Holiday called the worksession to order at 5:00pm. Councilmembers Ceasar Ruiz, Melody Ryan, and David Rogers were in attendance. Councilmembers Doug Weiss and Rudy Metayer joined the worksession at 5:01pm. Mayor Victor Gonzales joined the meeting at 6:00pm.

Joint work session with City Council and the Planning and Zoning Commission regarding the 5-year Capital Improvement Plan for FY2026-2030 related to drainage, facilities, parks, transportation, reclaimed water, water, and wastewater projects.

Mayor Pro Tem Holiday opened the item for discussion.

Planning and Zoning Commission members in attendance: Jonathan Coffman, Sally Decelis, Chelsea Burkett, Theresa Atkinson. Mr. Coffman called the Planning and Zoning Commission meeting to order and discussed the commission's recommended changes. Ms. Morrison introduced the 5-year CIP and Ms. Breaux provided information about what the plan consists of and discussed project selection and funding sources.

Mr. Groeschel reviewed the FY26 transportation projects including intersection control and improvements, and downtown mobility improvements. Ms. Ryan asked about traffic signal improvements. Mr. Groeschel provided information and answered questions from council regarding upcoming projects. Mr. Groeschel reviewed drainage projects and utilizing alternative funding sources. Mr. Coffman provided comment about drainage projects. Mr. Groeschel reviewed facility projects and answered questions from council

regarding the police department substation.

Mr. Achee reviewed the parks capital improvement projects and answered questions from council about the trails corridor study. Mr. Weiss and Ms. Ryan asked about Lake Pflugerville projects and phasing. Ms. Ryan asked about undeveloped parkland. Discussion followed regarding parkland and the current master plan. Mr. Pritchett reviewed the reclaimed water projects, water projects, and wastewater projects.

Ms. Morrison reviewed the schedule for adoption. Mr. Weiss asked about funding for projects and scheduling. Ms. Morrison discussed the factors involved in scheduling and stated it is reviewed every year. Discussion followed regarding impact of delays.
