

PROPOSAL AND BID SCHEDULE

Proposal of Muniz Concrete
& Contracting, Inc. (hereinafter called "Bidder"), doing business as a corporation / a partnership / an individual (strike out inapplicable terms), to the CITY OF PFLUGERVILLE (hereinafter called "Owner").

Gentlemen:

The Bidder, in compliance with your invitation for bids for the construction of the General Obligation Bond Trail Development Gap Project, having examined the Plans and Specifications and related documents and being familiar with all of the conditions surrounding the construction of the proposed project including materials and supplies, and to construct the project in accordance with the Plans, Specifications and Contract Documents, within the time set forth therein, and in performing the work required under the Contract Documents, of which this proposal is part.

Bidder hereby agrees to commence work under this Contract on or before a date to be specified in written "Notice to Proceed" by the Owner and to fully complete the project within 244 consecutive calendar days thereafter. Bidder further agrees to pay as liquidated damages to the sum set forth in the Special Conditions for each consecutive calendar day thereafter.

It is understood that the description of work to be done at unit prices is intended principally to serve as a guide in evaluating bids and is not intended to fully describe all work required.

It is further agreed that the work to be done and material to be furnished at unit prices may be increased or diminished as may be considered necessary in the opinion of the Engineer and approved by the Owner to complete the work fully as planned and contemplated, and that estimated quantities may be increased to cover additional work ordered by the Engineer and approved by the Owner, but not shown on the Plans or required by the Specifications, in accordance with the provision of the General Conditions. Similarly, they may be decreased to cover deletion of the work so ordered.

The foregoing prices shall include all labor, materials, removal, overhead, profit, insurance, etc., to cover the finished work called for. Changes shall be processed in accordance with applicable provisions of the General Conditions.

Bidder understands that the Owner reserves the right to reject any or all bids and to waive any informalities in the bidding.

In the event of a mathematical error, the correct product, determined by using the "Unit Price" and "Quantity", and the correct sum, determined by totaling the correct line item Amounts, will prevail over the amount entered by the Bidder. The unit prices shown above will be the unit prices used to tabulate the Bid and used in the Contract, if awarded by the City.

Contract time will be for an 8-month period.

The Contractor will base its bid amount on the CONTRACTOR'S unit prices and the estimated quantities of Work set forth in the Bid Form, which will only be used for the purpose of comparison and evaluation of Bids. The Owner will subsequently issue Work Assignments based on the Owner's needs and not in accordance with the estimated quantities contained in the Bid documents up to the aggregated Contract Amount of \$850,000.00, subject to further appropriations. The unit prices bid by the successful bidder shall remain firm throughout the period of the 8-month period of the CONTRACT.

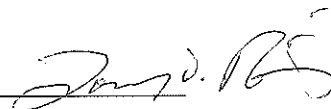
The Bidder agrees that his bid shall be good and may not be withdrawn for a period of sixty (60) calendar days after the scheduled closing time for receiving bids.

Upon receipt of written notice of the acceptance of this bid, Bidder will execute the formal contract attached within ten (10) days and deliver Surety Bonds as required by the Special Conditions.

The bid security attached in the sum of \$35,458.50 (five percent (5%) of the bid amount) is to become the property of the Owner in the event the contract and bond are not executed within the time above set forth, as liquidated damages for the delay and additional expense to the Owner caused thereby.

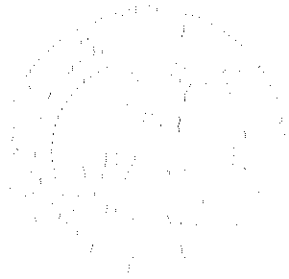
