Mayor Victor Gonzales called the worksession to order at 5:00pm. Mayor Pro Tem Doug Weiss and Councilmembers Ceasar Ruiz, Rudy Metayer, and Jim McDonald were in attendance. Councilmember Kimberly Holiday joined the worksession at 5:03pm. Councilmember David Rogers joined the worksession at 5:20pm.

#### **2A.** 2023-0803

Joint meeting with PCDC Board and City Council: Discussion and presentation from Ernst and Young, LLP, regarding the Pflugerville Community Development Corporation (PCDC) Comprehensive Economic Development Strategic Plan 3.0 (CEDS 3.0).

PCDC Board in attendance: Dennis Spencer, Adam Rosenfield. Amy Madison, PCDC Executive Director, introduced Tony Delisi with Ernst and Young. Mr. Delisi reviewed the CEDS 2.0 vision and goals. Ms. Madison reviewed PCDC highlights since 2017, reviewing businesses brought into the city and partnerships. Mr. Delisi asked what recent economic development success the council was most proud of. Discussion followed regarding partnerships, working with small businesses, and working with the city. Mr. Ruiz discussed wanting less industrial. Discussion followed regarding the need for corporate spaces. Mr. Rogers discussed importance of going after a big fish and discussion followed regarding what constitutes that. Mr. Metayer discussed the impact of higher education availability. Mayor Gonzales discussed the job market. Mr. Rosenfield provided information about workforce outreach. Mr. Metayer discussed needing places to put businesses. Mr. McDonald discussed bringing in supporting businesses and community development. Mayor Pro Tem Weiss discussed focusing on what to incentivize. Discussion followed regarding land available in the city.

Mr. Delisi discussed the City's strategic plan. Mr. Rogers discussed higher education. Mayor Pro Tem Weiss discussed retail recruitment. Discussion followed regarding the market and identifying who should be making moves. Mr. Delisi reviewed next steps including scheduling individual meetings to continue the conversation.
